- 4. Presentation on Dementia in the State Olmstead Plan.

Cheyenne Pasquale, Planning Chief, Aging and Disability Service Division, Lisa Watson, Social Entrepreneurs, Inc Client Services Manager

 The Olmstead Plan impacts those who are or can be unnecessarily institutionalized.

- People Living with Dementia/ Alzheimer's are recognized as persons who could be impacted.
- The ADSD Olmstead Plan Steering Committee will be a large part of developing the process (Charles Duarte serves as a TFAD representative on this committee)
- ADSD has a <u>Olmstead Planning link</u> for anyone wanting to follow or input on the progress.
- This is a yearlong process with efforts launching in Nov. 2022 ending in October of 2023.
- Phase one (November 2022-January 2013) is understanding the current reality. What areas work well and what needs improving.
- Phase two (January 2023-March 2023) is planning. What do we want
 the future to look like and what gaps can be addressed to help the
 maximum amount of people.
- Phase three (April-October) is intended to position ADSD for success, by establishing a framework that can measure progress.
- Twenty key informant interviews will be conducted to help determine how the system works and gain input. Nine consumer workshops are planned, including seven in person and two virtual.
- Development of goals and objectives to establish a clear framework will occur in phase three. Community feedback on the draft Olmstead Plan will be gathered as a final review before finalizing and implementing the plan.
- 5. Review and Approval of the TFAD's 2023-2024 State Plan: (For Possible Action)
 - Dr. Jennifer Carson motion to approve the TFAD 2023-2023 State Plan as written with the exception for final grammatical corrections.

 - An addition to the introduction was proposed to add a statement acknowledging that dementia will be added to the ADSD Olmstead State Plan.
 - Chuck Duarte motion to amend the motion to add the inclusion of the statement and for staff to make grammatical corrections as needed.
 - Tina Dortch second the amended motion.

 - Chuck Duarte second the motion.
 - A brief description will be added to detail the intent of the three new recommendations for 2023-2024, and the TFAD Chair/staff are authorized to review and make final grammatical revisions.
 - Gini Cunningham motioned to amend to include brief descriptions to the three recommendations.
 - Susan Hirsch seconded the motion.

 - Request to have discussions on concepts or topics (including the following: capacity; Olmstead Plan; preserving elder rights; Dementia Friendly Nevada; and lived experience of dementia).
 - Request for regular legislative session updates (perhaps Charles Duarte and/or ADSD staff)
 - Monitor 2 or 3 Recommendations per meeting.
 - Short-term priorities (March / May meetings) include Recommendations #8 (dementia training); #5 (DCS); #17 (Choice in Care).
 - Combine recommendations that have like interest like medical/legal rights.
 - TFAD acknowledged that there may be multiple presenters invited for any given topic.
