



Home Delivered Meals - FY 2016 Allocation





Waitlists for RD Unit Grantees' Critical Services


ADSD routinely conducts surveys of its grantees to identify waitlist and other service related information. The most recent waitlist surveys were conducted in April 2015 for Social Services and in July 2015 for Nutrition Services, to ascertain the current number of seniors waiting for critical services. The criteria for placing a "client on a waitlist" is: individuals who have been screened or assessed and determined eligible for the program but must be placed in a hold status until service slot is available.

Social Services

The Social Service survey was distributed as part of the FY 2016 Competitive Grant Application to 66 grantees, and had a 48 percent response rate (32 responses). These 32 responses

represented 70 programs. Of those, 27 programs (39%) use waitlists; 43 programs (61%) do not use waitlists. The responses were analyzed and these are the most significant findings.

- 1,407 seniors are currently waiting for <u>critical and needed services</u>.
- Seniors on waitlists wait from a day to over two years for needed services.
- 265 older adults are waiting for <u>Homemaker Service</u>, which is a person-centered homemaker and chore assistance service, provided to individuals, age 60 and older, who are unable to perform some or all of their desired homemaker services, due to identified functional deficiencies, and because they are in need of a support system to provide essential homemaker services.
- 213 seniors are waiting for <u>Volunteer Care Services</u>, which is supportive and assistive services for older individuals in their own homes, to help maintain their independence. Individuals needing services are typically alone and frail, chronically ill, homebound, and/or dependent on a primary caregiver. This service also provides health benefit counseling and assistance. - 201 older adults are waiting for Transportation Services, which provides safe transportation for access to services such as nutrition, medical services, social services, adult day care, shopping and socialization.
- Other services with large waitlists include Food Pantry (174), Home Service and Vehicle Modification (154), Voucher Services (105), Companion Services (101), and Representative Payee (97).




As mentioned in Appendix B of the State Plan, Nevada's economic recession combined with its high growth rate in the numbers of Nevada elders has greatly affected community based organizations' ability to meet the demand for services. To help ensure essential services are available for seniors, the Division developed its Core Services funding model, which identifies priorities in service funding as the available money decreases. Core Services includes those services that can directly prevent nursing home admission.

Length of Wait Time

Thirteen services with the longest waitlist, ranked from longest to shortest waitlist include: Representative Payee; Homemaker, Case Management, Caregiver Supportive Services, Home Services and Vehicle Modifications, Food Panty, Transportation, Volunteer Care, Lifeline, Adult Daycare, Respite and Supportive Services, Companion, and Voucher Services.

Reasons for Waitlist: Community Partners provided reasons for wait time (see below), which varied somewhat, but a recurring reason for putting seniors on waitlists is "lack of funding." Based on the survey conducted in April 2015, partners reported the most significant numbers on waitlists in the following service categories.

Agencies with waitlists are categorized under the services provided.

Representative Payee

• Clark County Public Guardian with 97 clients waiting 754 days for services.

Homemaker

- Nevada Rural Counties RSVP with 195 clients currently waiting for services.
- Washoe County Senior Services with 46 clients waiting 182-365 days for services.
- Mt Grant General Hospital Home Health with 18 clients waiting 371 days for services.
- <u>Pleasant Senior Center</u> with 4 clients currently waiting for services.
- <u>Lincoln County Human Services</u> with 2 clients currently waiting for services.

Case Management

Washoe County Senior Services with 46 clients waiting 182-365 days for services.

Caregiver Supportive Services

• Elko Family Resource Center with 9 clients waiting 365 days for services.

Home Services & Vehicle Modification

- <u>Jewish Federation of Las Vegas / Las Vegas Senior Lifeline</u> with three (3) clients waiting 60 days for services.
- Nevada Senior Services, Inc. with 151 clients waiting 356 days for services.

Food Pantry

• <u>James Seastrand Helping Hands of North Las Vegas</u> with 174 clients waiting 275 days for services.

Transportation

- Helping Hands of Henderson with 133 clients waiting 180 days for services.
- Nevada Rural Counties RSVP with 68 clients waiting 270 days for services.

Volunteer Care

- <u>St. Rose Dominican Helping Hands of Henderson</u> with 133 clients waiting an average of 180 days for services.
- <u>Sanford Center for Aging, UNR</u> with 49 clients waiting an average of 220 days for services.
- Nevada Rural Counties RSVP with 31 clients waiting a maximum of 120 days for services.

Lifeline

• Nevada Rural Counties RSVP with 3 clients waiting a maximum of 120 days for services.

Adult Daycare

- Nevada Senior Services, Inc. with 20 clients waiting 60-90 days for services.
- Washoe County Social Services with 4 clients waiting 114 days for services.

Respite and Supportive Services

• Nevada Senior Services, Inc. with an average of 15 clients waiting 60-90 days for services.

Senior Companion

• Seniors In Service with 101 clients waiting 60 days for services.

Voucher Services

- Alzheimer's Association, Desert Southwest with 67 clients waiting 29 days for services.
- <u>Seniors In Service</u> with 38 clients waiting for services.

Eight (8) services identified wait times greater than six (6) months: Representative Payee, Homemaker, Case Management, Caregiver Supportive Services, Home Services & Vehicle Modification, Food Pantry, Transportation, and Volunteer Care. The services with the longest wait times are Nutrition Services and Home Delivered Meals, per the following page.

Nutrition Services

A Nutrition Grantee Survey was conducted July 23, 2015 - August 3, 2015 as part of the FY 2016 Competitive Grant Application to identify Waitlists by Program. The survey had 23 respondents; only two (2) programs indicated waitlists, with waiting times ranging from 14-90 days.

- 613 seniors were waiting for Home Delivered Meal Services.
- Seniors are on waitlists wait from 14-90 days before they are able to receive this critical service.
- Catholic Charities of Southern Nevada with 593 clients waiting 14-90 days for services. ADSD increased Catholic Charities' FY 2016 funding amount by \$561,238 over its FY 2015 budget to help resolve this waitlist.
- <u>City of Henderson</u> with 20 clients waiting 20 days for services. ADSD increased the City of Henderson's FY 2016 funding amount by \$3,115 over its FY 2015 budget to help resolve this waitlist.

With the federal restoration of Sequestered, Title III-C funds, ADSD was able to totally eliminate these waitlists in October, 2015.
