Mr. Scott Youngs recommends when the AT Council goes to the legislature they have as many users of AT to advocate for themselves as he feels it would have a better impact on Legislators.

He suggests that the council works on sending a letter to educate them on how to be more accessible for the public and individuals with disabilities. Ms. Dora Uchel mentioned that the family engagement council membership was not very accessible as she went online to fill out a form and it was not accessible. She said it took a while to hear back from someone with the school district to get back to her with a fillable form. She also expressed interest in engaging with the legislature but she would need transportation. The National Federation of the Blind will be at the Legislature, for BDR 172 about parental rights bill, on March 13<sup>th</sup> from 10:00 AM to 4:00 PM she was looking for support from the council.
