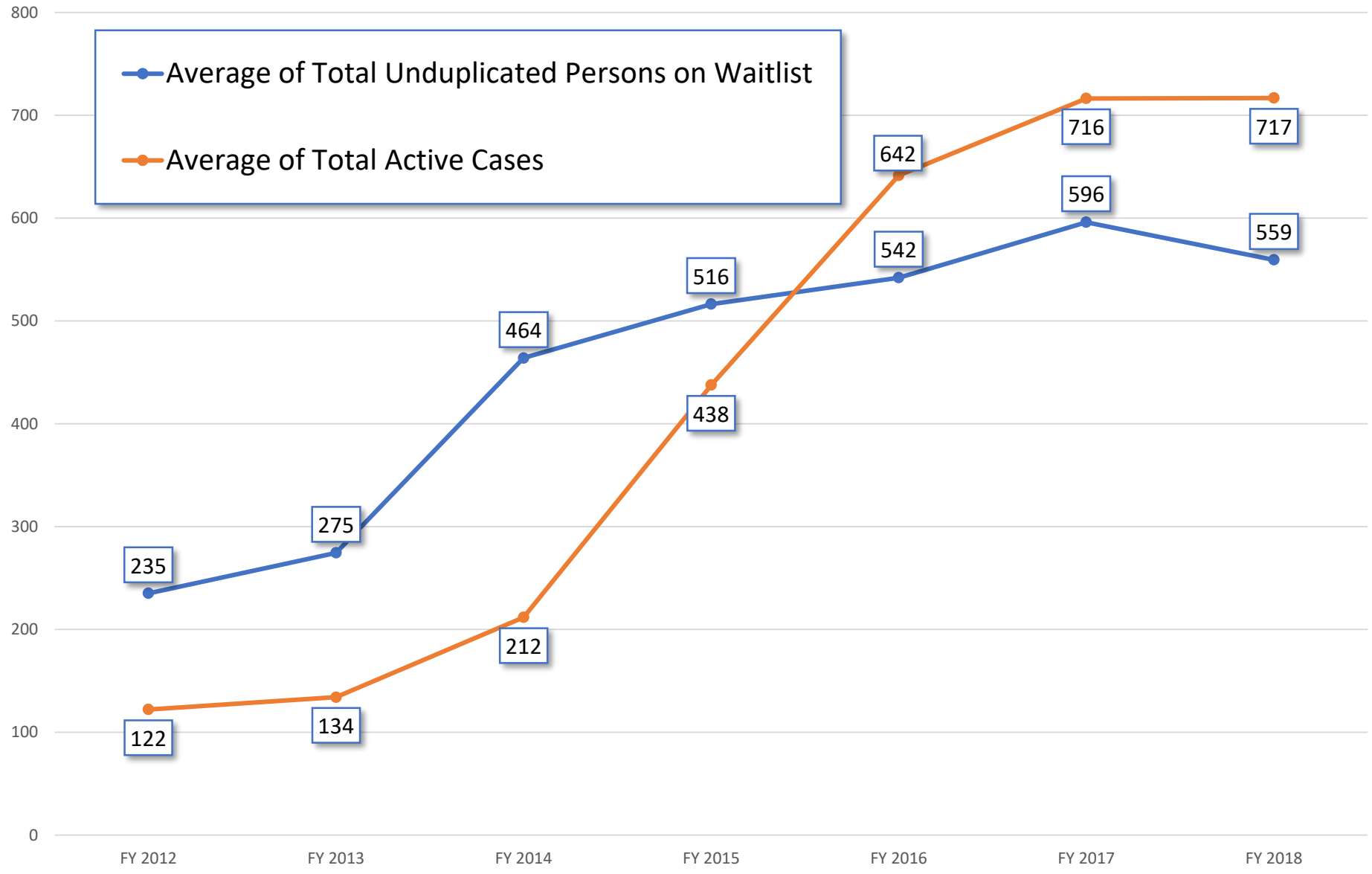

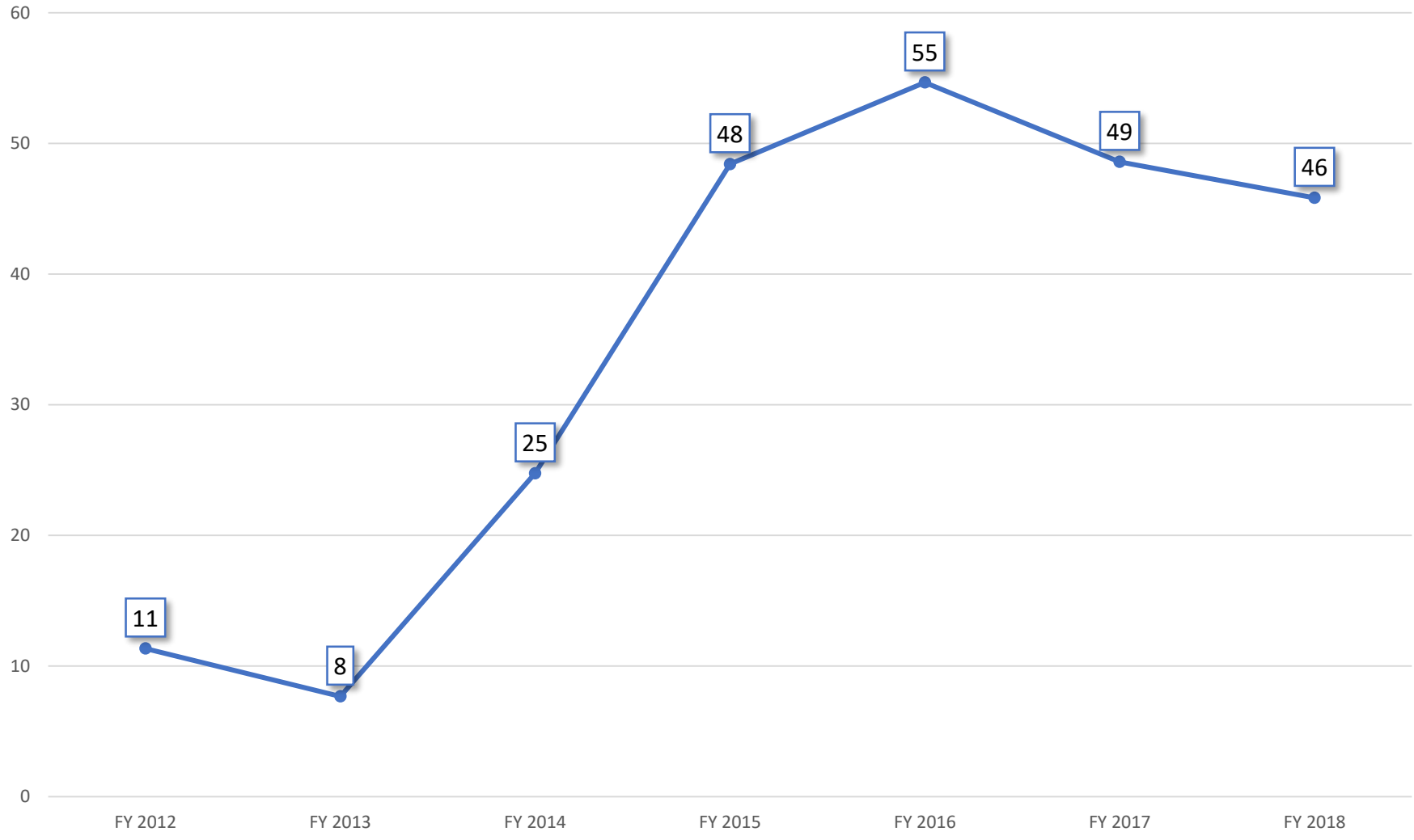
- June Monthly caseload to date (6/30/18)

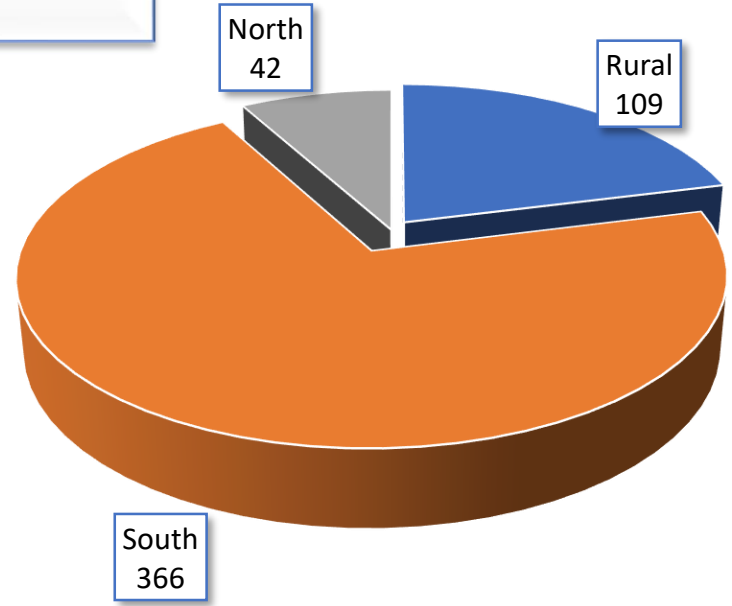

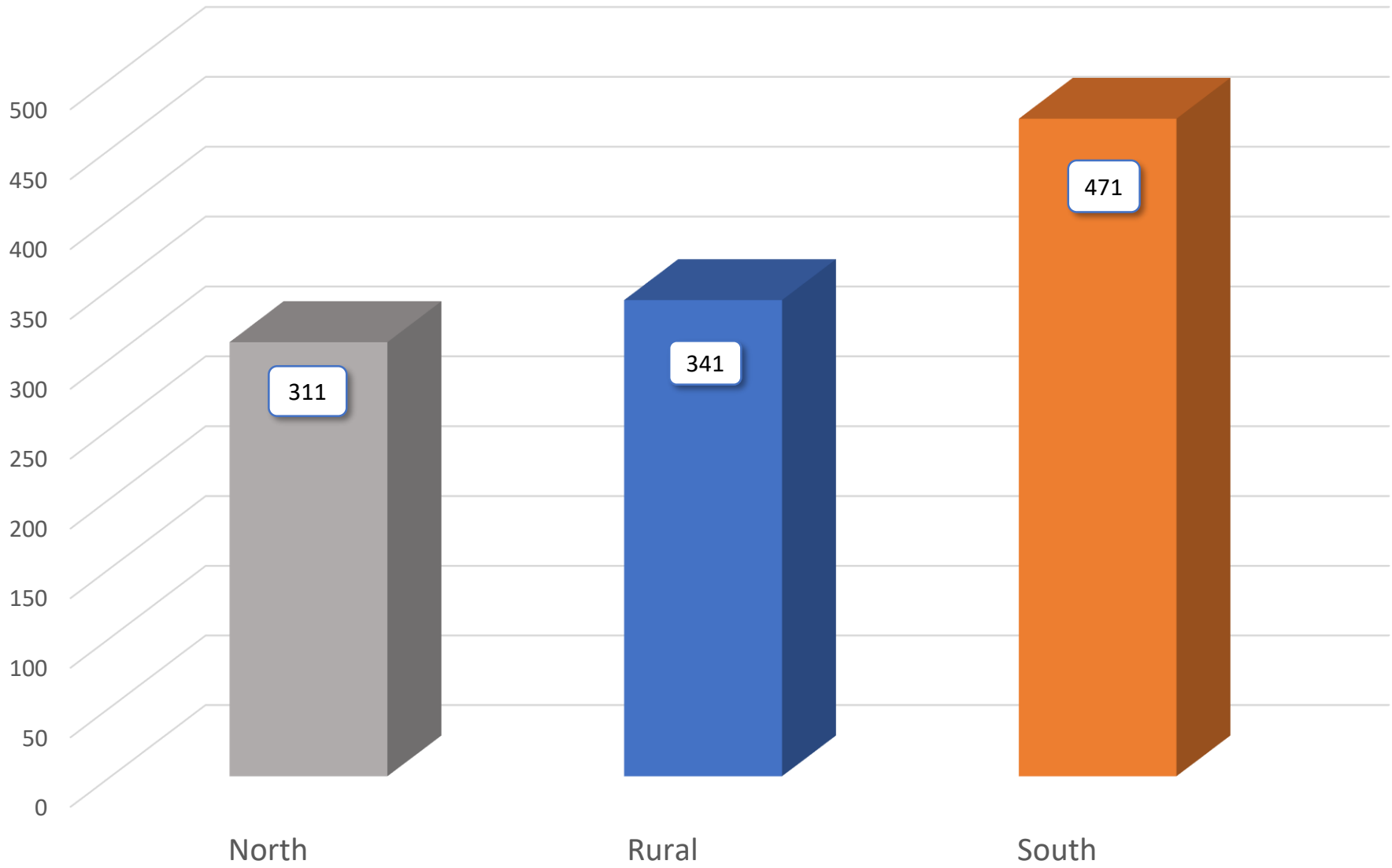

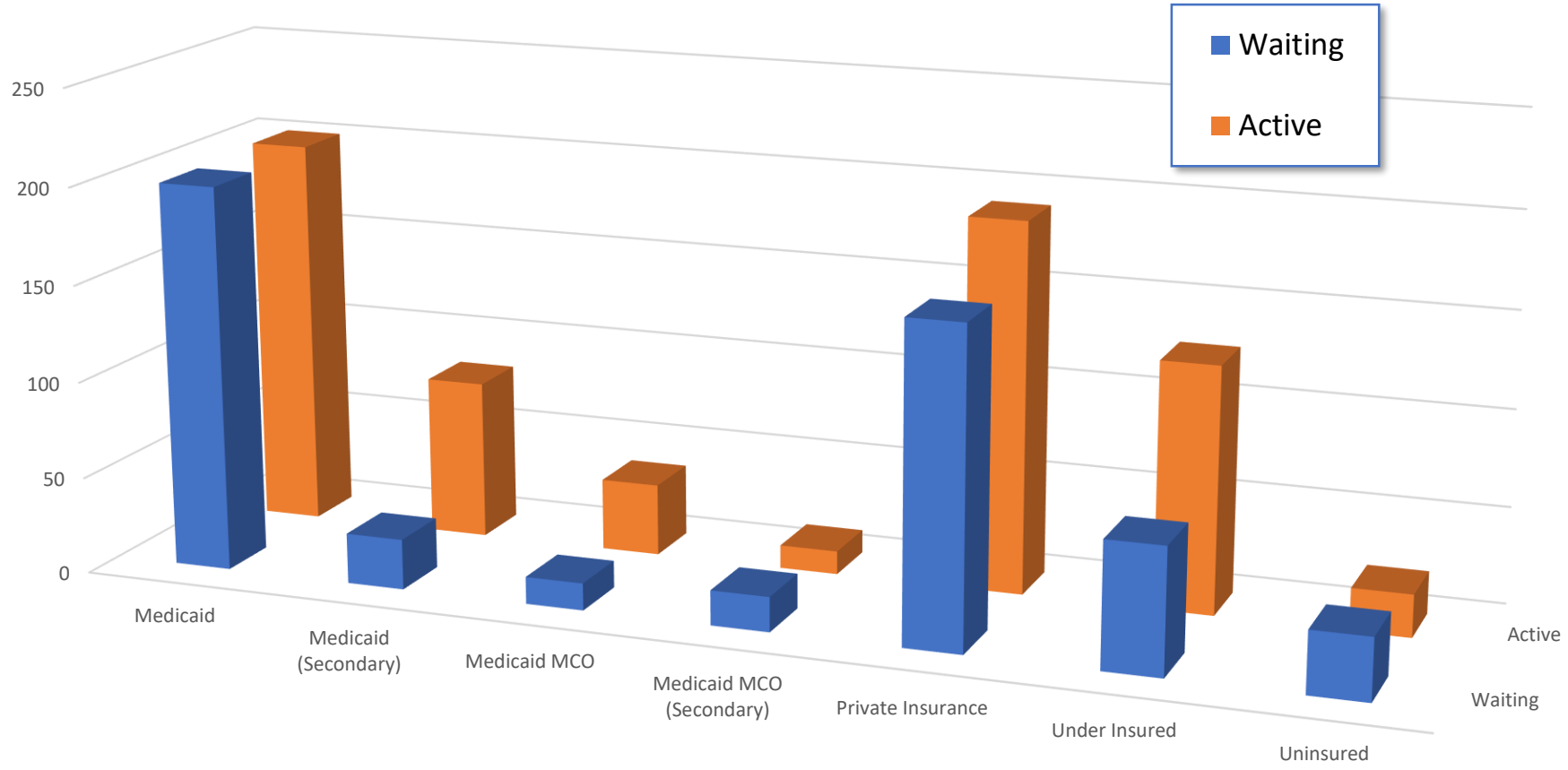


Wait Time by Area

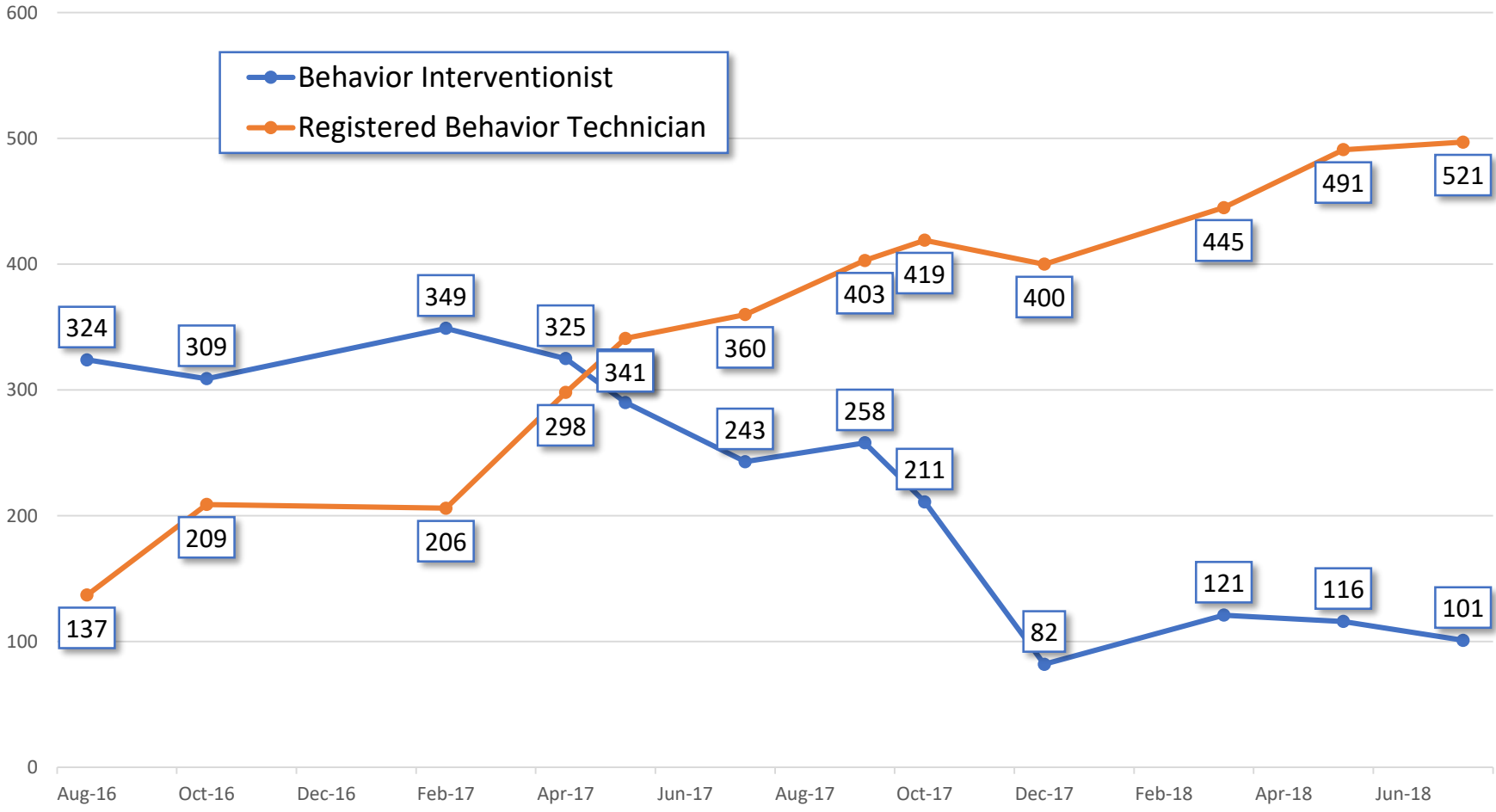
AVERAGE WAIT IN DAYS
