## **Autism Diagnosis Services Report**

This report is a result of a request from the Commission on Autism Spectrum Disorder (ASD) to provide service data on children in the Early Intervention Program with a diagnosis of ASD.

Early Intervention (EI) is a comprehensive statewide system for children, ages birth to three years of age, with developmental disabilities and their families. The EI system includes children who are served by Nevada Early Intervention Services (NEIS) State Programs and Comprehensive Community Provider Programs contracted through Aging and Disability Services Division (ADSD).

El provides services and supports individually designed to help families meet the specific needs of their children in accordance with Part C of the Individuals with Disabilities and Education Act (IDEA) to include:

- Audiology
- Family Training and Counseling
- Health Services
- Medical Services for diagnostic and evaluation purposes
- Nursing Services
- Nutrition Services
- Occupational Therapy
- Physical Therapy
- Psychological Services

- Special Instruction
- Speech Language Pathology
- Transportation
- Vision Services

This report shows the services received by EI children who have been diagnosed with ASD. This is point in time data; as of the data extraction, 78 children have been identified as having ASD (2.5%) out of 3,052 total active caseload.
