Steven Cohen commented that the NVCASD Subcommittee on Adult Services and Resources is scheduled for tomorrow morning at 7:00 am. He also stated that there may be a new way to resume the Anthem contract with Medicaid. There are also some issues with the state website that disbanded the Taskforce on Integrated Employment webpage with information regarding the sate strategic plan. Ms. Adie stated that she will reach out to the contacts she has with the Division of Insurance. Mr. Cohen also clarified that the Governor's Executive order for the Commission expires June 2018.

Ms. Adie made a recommendation that the subcommittee identify relevant items in the Affordable Care Act (ACA) that provides benefit to the community and certain service coverage, a letter can then be drafted and send it to the Governor's office. Ms. Adie and Ms. Partos will work on developing a list of priorities under the ACA for the Subcommittee. Ms. Partos stated concern on a federal level with a new tax bill, regarding medical bills exceeding ten percent of an adjusted gross income, deductions can be made in an excess of that cost.

Ms. Adie stated that the report to the Governor is due every December and June of each year.

Ms. Gaw contacted a collegue and occupational therapist from pennsilvania who is well versed in the (DIR) floor time therapy model. She made an offer to attend a subcommittee meeting and address the topic and answer questions.

Ms. Adie clarified that ATAP does fund a small amount of children who need OT, PT and speech therapy. They cannot access ABA and the oher therapies at the same time under ATAP. Medicaid and other private insurance companies usually cover other therapies and not ABA.
