Case Study #2

- Infant Hearing Programs (IHP)
 Goal to Meet JCIH Guidelines of 1, 3 and 6 months through implementation of a new State infant hearing reporting and tracking system
 - Coordinate Design, Testing and Implementation of State IHP system to
 - Allow immediate reporting of hearing outcomes by hospital nurseries
 - Flag birth records not tested prior to discharge
 - Provide Patient scheduling for follow up hearing testing at clinic or audiologist
 - Allow clinics and audiologists to report results and no-shows real time for follow up by the State
 - Facilitate IHP and Vital Records electronic systems linkages for
 - Immediate flagging of birth records with no hearing test
 - Providing letter explaining the importance of early detection and list of testing providers when parents request birth certificate
 - Notification at IHP so that state staff could follow up with parent
 - Provide End User IHP Electronic System Training to users at all State Birth Hospitals, Clinics and other Birthing facilities

Case Study #3

- Facilitate Strategic Plan for Substance Abuse Prevention and Treatment Agency (SAPTA) to Prepare SAPTA Providers for Medicaid Billing Process
 - Set strategic direction with various stakeholder groups within and outside of the Agency
 - Facilitated communication between State and 16 provider groups
 - Worked with Providers to understand current state of affairs and assisted them to develop strategies needed to move forward with new billing processes
 - Created customized training materials for Provider processes
 - Facilitated transition to Medicaid billing
 - Coordinated with Providers and State to implement strategies
 - Successfully coordinated multiple stakeholder groups with varied goals to develop strategic direction and achieve it


