- 4. Updates from the Chair and Director

Eli Schwartz, Commission Chair and Cheyenne Pasquale, Director

- SB93 was approved in June and almost everything requested was approved Commission name change, paid Directors position, additional commission members, bring the total to 11, and the Commission in now under ADSD and not the Governor's office. The additional \$25,000 was not granted.
- SB203 is a significant bill that allows a child under the age of 13 and under 400% of the poverty level to apply for hearing aids at no cost or low cost. ADSD is responsible for creating and administering the program.
- SB203 also requires an establishment of a committee for the development of language and literacy program.
- Three commission lead townhalls were done with the commission obtaining several topics they can help address throughout the state.
- The Executive Director position that was approved by the Legislature has been sent to the Interim Finance committee (IFC) to be incorporated into the agency budget under the TDD surcharge. It has to go back to the IFC in October before recruitment can begin.
- 5. Report from the Communication Access Services Program, including presentation of proposed NAC changes for Interpreter Registry (For Possible Action)

Sal Fiorientino, CAS Program Manager and Jennifer Montoya, SSPS II

• New Interpreter Mentor was hired for the South

- The Mentorship program is up and running, 19 applications have been received, 12 mentees have been placed with 4 CAS interpreters and a wait list has been established.
- The interpreters in the north provided a 4-day workshop to local interpreters on discourse mapping. The same program is being developed by the south interpreters.
- The CAS team is working on updating the Nevada Administrative Code (NAC 656A). NAC 656A is the regulation for interpreters and CART provider and sets the requirements for educational and community interpreters. A public workgroup is being planned with several ways to attend the meetings allowing for as much feedback as possible.
- 6. Update on Nevada Relay Services, including introduction of new provider Sprint and Hamilton Relay
 - Sal Fiorientino, CAS Program Manager and Jennifer Montoya, SSPS II
 - Relay Nevada is transitioning between providers, the new relay provider is going to be Sprint. Sprint will provide Nevadans with access to Relay Nevada that enables them to make phone calls whether it's TTY or a CapTel phone. Sprint will have two-part time outreach specialists to provide outreach statewide including rural areas.
- 7. Discussion and Interviews for Commission Membership (For Possible Action)

 - Sharon Warren and Susan Becket were both given the opportunity to tell the commission about themselves and then were asked the same three questions.
