Successes and Wins

- Accomplishments above and beyond what is reported to our grantors:
 - June 2020's cumulative engagements provided to stakeholders from all direct service platforms within DCN, including data reported to our grantors, totaled 8,469.
 - In average over the last 3 months DCN has doubled in engagements since our last Commission Report. This momentum is a great reflection of the due diligence of our dynamic Advocates, Specialist, Providers, and community members coming together to enrich our community services and access.

Collaborations and Service Expansions

- Updates on any partnerships established, new or existing:
 - DCN currently holds 12 collaborative allies (aids in resources, community platforms, and/or events), 62 partners, with 30 potential partnerships in the works.
- Updates on expanded services outside of our grantors:
 - Internship opportunities have shown to strengthen our presence in the community among college students at CSN and NSC, schools in which interpreting courses are offered.
 - SB203 Hearing Aid Program:
 - In our efforts to get this program up and running our Hearing Loss
 Advocate and Executive Director have found that there are issues in the

- DCN Executive Director is working closely with the Commission Subcommittee and Deaf and Hard of Hearing (D/HH) Health Equity Alliance to seek the proper changes to aid in increasing the accessibility of hearing aids to our D/HH constituents through this program.
- DCN Executive Director and the Commission's Education Subcommittee have also discussed the funding aspect of the SB203 Hearing Aid Program and the limitations the current budget presents. This is still under discussion and will be best presented once the program becomes more accessible as we build fluency of services through the law as it stands.

Community Challenges

- Challenges or opportunities to improve services for the target population:
 - DCN has seen an increase in the needs of our homeless population as there is a lack of resources with language access for the D/HH populations. The service challenges pertain to shelter, nutrition, and access to virtual assistance via cellphone, tablet, or computer.
 - DCN continues to ally with local representatives (North and South) to educate and impower organizations to expand their scope to include accessibility points within their current practices.
 - The need for employment continues, yet as DCN has provided resources with Unemployment the community has shown little interest as a collective. Though we have received multiple calls seeking direction and assistance when open platform discussions are presented clients and community members shy away and/or do not show up via virtual outlets.
 - This can be perceived as a lack of virtual access to current platforms engaged.

Recommendations for the Commission

- Decisions/recommendations needed by the Commission (if any):
 - The Subcommittee is already addressing the concerns of the SB203 law as it is currently written. DCN has no other decision/recommendations to present to the Commission.
