Successes and Wins

- Accomplishments above and beyond what is reported to our grantors:
 - September 2020's cumulative engagements provided to stakeholders from all direct service platforms within DCN, including data reported to our grantors, totaled 14,240 organization wide (current updates for October in progress).
 - In average over the last 3 months DCN has seen a steady increase in engagements since our last Commission Report.

Collaborations and Service Expansions

- Updates on any partnerships established, new or existing:
 - DCN currently holds 59 collaborative allies (aids in resources, community platforms, and/or events), 62 partners (114 partner contacts), with 28 potential partnerships in the works.
- Updates on expanded services outside of our grantors:
 - No current updates though the DCN Executive Director has continued providing feedback to the Commission as it pertains to the funding aspect of the SB203 Hearing Aid Program and the language currently stated within the NRS.

Community Challenges

- Challenges or opportunities to improve services for the target population:
 - In speaking with our staff, we are getting reports of the following:

- Community members having a hard time finding audiologist that are affordable WITHOUT insurance.
- Lack of D/HH education/support within the school system due to Social Distancing.
- Reports from the community having challenges with obtaining interpreters at DMV. Our advocates are working closely with the concerns.
- Social distancing remains to present challenges for cultural needs of the community as a whole and DCN is see a higher rate of virtual fatigue.
- Slower family and children engagements virtually due to exhaustion or lack of WiFi/internet services in the rural areas.
- The need for employment continues.
- There is also an influx of need for Technology, yet clients are seeking for in home repairs or installations that DCN is not yet prepared to support.
- DCN is experiencing a hiring freeze that has presented challenges of meeting the demands of the community.
- DCN in general is struggling with diversifying funding as COVID and social distancing has limited our Board and Staff's outreach efforts.

Recommendations for the Commission

- Decisions/recommendations needed by the Commission (if any):
 - The Subcommittee is addressing the concerns of the SB203 law as it is currently written. DCN has no other decision/recommendations to present to the Commission.
 - DCN does seek additional input from the Commission for ideas of possible connections with affiliates in our efforts to diversify our funding.
