#### 2. Approval of the July 8, 2020 Meeting Minutes: (For Possible Action)

Eric Wilcox moved to approve the minutes; Laura Fink seconded. Minutes were approved by majority vote.

### 3. Discussion and Approval of Recommendations from the Director and Chair reports: (for Possible Action)

Khianti Thomas, Executive Director and Eli Schwartz, Chair

- Nevada Department of Health and Human Services recently launched a new contact digital tracing app for COVID-the app is called COVID trace.
- Deaf Awareness month- Khianti will be collaborating with DCN to highlight CDI/ DI and Deaf Owned businesses throughout the month
- COVID-19 communication card has been sent to the governor's office and awaiting approval to be published with the State seal.
- Annual report has been drafted and available for public comment. Eric motioned to approve the report pending the edits, Susan Beckett seconded.
- Senator spearman wanted to be sure we were aware of two things. SR 1-ensure public health crisis magnified by COVID-19. And AB4, which is regarding election procedure for absentee ballots and other mail ballots
- Legislative subcommittee on healthcare did not provide us with a BDR
- Will Jensen sent an email that they will resume the SB203 subcommittee
- Eli has been invited to participate in SILC's legislative subcommittee

### 4. Report and Discussion from Nevada Office of Minority Health and Equity (NOMHE):

Tina Dortch (MPA), Program Manager

- Tina shared information regarding NOMHE including but not limited to the history, strategic partner contracts, and the primary functions of NOHME.
- Discussed the purpose of developing the DHH Alliance per Senator Spearman's request to focus on SB203 and realized this could be a conduit to the commission.
- Question raised: Does the state track data on disparities in health outcomes? There is currently another work group that was initiated to promote the collection of stratified data for these outcomes

### 5. Report and Discussion from the Communication Access Services Program:

Salvatore Fiorentino, CAS Program Manager

- Relay Nevada had 119,444 calls made through Relay Nevada. There was a spike in numbers from March- May due to COVID 19. This was the highest number of calls compared to the last three fiscal years.
- TRS minutes has increased to 11,000 minutes in March, normally it is roughly 8,000. CapTel had a large spike as well
- Sprint and T-Mobile merged, Sprint should be doing TV commercials this
  month and they will be aired in Northern and Southern Nevada. The
  commercials started in August and will continue through October. They will
  be emphasizing internet based CapTel
- In addition to these commercials news stations are going to be interviewing different customers of the service utilizing CapTel. This advertising will result in more inquiries to Relay Nevada, CapTel and Deaf Centers of Nevada.
- During fiscal year 2020 4,430 eligible consumers who were served at DCN.
  This number is a major increase in consumers served, mostly due to the
  increase of service delivery including ASL classes. Those classes typically
  serve one to 400 individuals each month. These total numbers also include
  DCN's other core services, which include the telecommunication
  equipment, assistive technology, the hearing aid program, language
  acquisition, and access to services.
- During fiscal year 2020, there were 17 mentees who were being served, in the first quarter they started with 12, and it grew to 17 by the fourth quarter. There has been a significant decrease in those interpreting hours during the fourth quarter, and obviously the reason for that reduction in hours of providing interpreting services is related to COVID-19. By the fourth quarter they were down to only 38 hours provided.
- 222 total interpreters registered with the state of Nevada, they project for FY 21 there will be a large increase. The CAS program has also provided multiple workshops which had led to the increase as well

#### 7. Report, Discussion and Approval of Recommendations from the Deaf Commission Outreach Subcommittee: (For Possible Action)

Khianti Thomas, Executive Director

- Catherine Nielsen accepted the role of being the Chair for the outreach subcommittee
- The Commission PowerPoint presentation was approved pending a few edits.
- The following recommendations prioritized by the outreach subcommittee have been approved by the majority:
  - Partner with NGCDD to promote Partners in Policymaking class to the Deaf and Hard of Hearing community. The Deaf Commission could help support accommodations or supplies needed for the

- class. (side note: this would cover several activities that are assigned to the outreach subcommittee).
- Prioritize Deaf and Hard of Hearing cultural awareness training to mental health providers, working with partners such as Deaf Centers of Nevada and the State Licensing Board. Offer workshops through Zoom or other virtual methods.
- Conduct Legislative Overview training and awareness to the Deaf and Hard of Hearing community, including parents of children prior to the beginning of the Legislative session. (starts...beginning of February, promote Advocacy day at Legislature).

#### 8. Report, Discussion and Approval of Recommendations from the Deaf Commission Education Subcommittee: (For Possible Action)

Eric Wilcox, Co-Chair

- The subcommittee has met twice in the last couple of months, and focused on revisiting and reviewing the four strategic objectives related to education that were in the state Strategic Plan for the Deaf and hard of hearing.
- Standards for educational interpreters were discussed, extensive input was shared from Jenn Montoya on the efforts to evaluate the standards of educational interpreter across the state. The results of that were efforts to mentor and raise the standards, as well as the efforts to amend the code in the state to raise the standards. This is currently in progress.
- Discussion of implementation of the communication plan for IEPs or individual's education plans for Deaf and hard of hearing children in the school system with the help of Daina Loeffler
- Nevada Hands & Voices is rolled out their advocacy program and completed four Saturdays of training that were open to the public.
- Extensive discussion in the last meeting about older children transitioning out of the school district and into higher education or employment. More information can be found in the meeting notes.

### 9. Report, Discussion and Approval of Recommendations from the Deaf Commission Legislative Subcommittee: (For Possible Action)

Eli Schwartz, Chair

- High level discussion regarding the 911 to text option
- Discussion whether we should define American Sign Language being ASL, as a protected language. More research will need to be done to see if there is a possibility to work with insurance companies to determine who will cover the costs associated with professional support interpreters. Eric agreed to head the workgroup to do the research.
- Discussion of the Deaf School
- Motion was made by Eric for Khianti and Eli to make edits to the hearing loop letter and send it to state and city officials to inquire what they are doing to be compliant with the ADA. The motion was seconded by Laura Fink, all majority was in favor
- Recommendation to allow Khianti as the ED to discuss alliances with other advocacy groups to create a letter to educate legislators and others on the use of appropriate language. Specifically removing the word "hearing

- impaired" from the NRS and changing it to "Deaf and Hard of Hearing". Jeff motioned to approve, and Eric seconded.
- Recommendation to modify the language in SB203 to state the following: "if have no insurance, no access to insurance, or unable to pay premium/co-pay the program pays for hearing aids and related costs such as ear molds and batteries, and/or consistent with paying the premium and co-pay for insurance that will pay for the hearing aid and related costs." Eric made a motion to approve that the commission sends a letter to Senator Spearman requesting that we seek a change in the language as aforementioned. Susan Beckett seconded the motion
