- Strategy 1.3.1-
 - Request information from Jennifer Montoya, Communication Access Services (CAS) what are the certification level for interpreters that work for the School District? Do the rural areas have adequate interpreters? Are the Districts meeting the goals ?
 - What barriers do Community Interpreters with a 4.0 level or higher have in getting certified as an Educational Interpreter?
