- 2. Continuation of Discussion and Approval of Legislative Activities from 1.14.2021 meeting (For Possible Action)
 - Khianti Thomas, Executive Director
 - Extended discussion regarding legislative activities from the previous meeting. The Commission decided to go with the suggestions made by Laura. Eric made the motion, Laura seconded. All were in favor.
- 3. Review Discuss and Approve Testimony for (AB14, AB35, AB62, AB63, SB5, SB70, SB56, SB76) (For Possible Action)

Eli Schwartz, Chair

AB14: Revises provisions relating to emergency management.

AB35: Revises provisions governing certain programs to assist senior citizens and persons with disabilities with costs relating to health care.

AB38: Revises provisions relating to career and technical education and workbased learning.

AB62: Revises provisions relating to the Nevada ABLE Savings Program. (BDR 38-397)

AB63: Makes various changes relating to the financial administration of local governments.

SB5: Makes changes relating to telehealth. (BDR 40-416)

SB56: Revises provisions governing insurance coverage of behavioral health services. (BDR 57-124)

SB70: Revises provisions governing mental health. (BDR 39-418)

SB76: Revises provisions relating to education. (BDR 34-297)

- The Commission had a productive discussion regarding each bill and made the following edits to the language below:
 - AB414 Relevance statement is okay. Would like to add language related to CDI and appropriate accommodations in emergency preparedness.
 - AB35 broaden the definition of disability to physical, sensory, emotional, or intellectual disability.
 - SB5-Telehealth should be accessible to deaf and hard of hearing patients, which includes access to providers who are knowledgeable in the service to deaf and hard of hearing community...add Deaf Blind and funds for.
 - SB56-ensure services are accessible (similar to SB5).
 - SB 70-Training should be provided to ensure cultural sensitivity of the deaf and hard of hearing community; also, accessible, effective communication within the mental health facilities.
 - AB63-more impact for our testimony from AB14, relevance good to go otherwise.
 - AB38- Education subcommittee might want to watch this issue over time but will not remain on the watchlist for this session.
 - SB76- continue to watch to see if SB203 subcommittee comes up in discussions.

• Laura made a motion to approve the current watch list and added recommendations for testimony. Susan seconds the motion, all in favor.

4. Discussion and Approval of Recommendations of Strategic Plan (For Possible Action)
