 Nevada Division of Public and Behavioral Health, Department of Health and Human Services(DHHS) received a grant of approximately \$200,000 from the Centers for Disease Control (CDC) Bold Act Funding to support brain health promotion and raise awareness of Alzheimer's across the state.

- The National Alzheimer's Association also received Bold Act funding to launch a national public health center of excellence on dementia risk reduction.
- Cleveland Clinic received an exploratory grant from NIA to being work developing a new Alzheimer's Disease Research Center.

4. Presentation/Updates Division of Public and Behavioral Health (DPBH) Awareness Campaign

Chuck Duarte, Dementia Care Director, Alzheimer's Association of Northern Nevada & California

- The Division of Public and Behavioral Health(DPBH) originally provided a grant of \$800,000 to fund Alzheimer's and Dementia awareness campaign in Nevada.
- Over 5.8 Million Adults are affected by Alzheimer's
- 5th Leading cause of death for those over 65
- Nationally cases to rise 6.7% between 2020 & 2025
- Health disparities affect the African American and Hispanic populations.
 Getting an early diagnosis is key.
- Nevada has the third fasted rate of growth with an expected 64,000 cases by 2025.
- Nevada Medicaid has spent more that \$200 million on health services and long-term care.
- An estimated 153,000 in unpaid caregiver hours valued at \$2.3 billion just in Nevada.
- A Project Team has been established with members from both Northern and Southern Nevada chapters of the Alzheimer's Association.
- The Alzheimer's Association of Northern California and Northern Nevada were awarded a two-year CDC sub-grant in September of 2019 that will end in June of 2021.
- The primary goal is to increase awareness Alzheimer's disease, warning signs and the benefits of early detection.
- A budget has been implemented to cover the cost of TV, radio, print, and digital advertising.
- A reduction for media spending was implemented in June from \$150,000 to \$81,000.
- Due to budget reduction the focus was moved to digital with some funds going to TV and radio.
- Two critical partners are Nevada Department of Health and Human Services and Nevada Care Connection.
- A specific Nevada landing page will be created on the National Alzheimer's Association Chapters website for Nevada residents to access the Call to Action information and a 24/7 Alzheimer's Association Helpline.
- By using resources that the National Alzheimer's Association has in place no grant money will need to be spent on development and all the resources are available to be shared.
- This platform is being developed to be self-sustaining with minimal upkeep with potential outside source funding.
- Expected campaign launch is September 2020 through June 2021 with

digital and social media first followed by TV and radio October/November 2020.

 The Know Where Alzheimer's Hides campaign is a National campaign that started in Wisconsin.
