- Peter Reed, PhD welcomed three new members to the Task Force Connie Johnson, Wendy Knorr, and Jennifer Carson, PhD
- Connie Johnson (Member at Large) - Currently works at the Northern Nevada State Veteran's Home and has Involved in Health Care for 40+ years with a special interest in Alzheimer's and Dementia. Connie is excited to be a part in helping initiative's push forward helping families and people affected by Alzheimer's and Dementia.
- Wendy Knorr (Representative of Providers of Services for Persons with Cognitive Disorders) - Is transitioning to Mission Senior Living after many years of services helping advocate for people with Alzheimer's & Dementia. Wendy is interested in furthering education, support, and advocacy in all Dementia related areas.
- Jennifer Carson, PhD, (Caregivers for Persons with Cognitive Disorders) – On Faculty at the University of Reno (UNR) School Community Sciences. Working with two different initiative's; Dementia Friendly Nevada and Nevada Ensures Support Together (NEST). Jennifer is honored to working with partners supporting the statewide initiative to fight Alzheimer's and Dementia. Jennifer brings to the table the knowledge and perspective of both the professional care partner and family care partner.
- Special Legislative Session Susanna Powers (Chief Economist for the Governor) noted several cuts one being a 16.9 Million Dollar cut to Healthy Nevada (tobacco master settlement agreement money) these funds pay for independent living grants and respite care throughout the state. It is unknow what affect this will have in these areas. Director of Health and Human Services Richard Whitley was scheduled to present to the Assembly. It is unknown if the grants that were approved for Fiscal year 2021 will be honored or cuts imposed.

## 4. **Nomination and Election for TFAD Chair and Vice Chair (For Possible Action)**

- Peter Reed self-nominated to continue as Chair for the next year no other nominations were presented.
- Peter Reed Nominated Tina Dortch a Vice-Chair Jennifer Carson second Tina Dortch accepted the nomination, no other nominations were made.
- Chair and Vice Chair were taken as a slate, Chuck Duarte accepted the slate, Connie Johnson second the motion, all approved the motion passed.

## 5. **Presentation/Updates from the Humboldt General Hospital EMS on Care Transitions**

Jordan Kohler, Interim Director HGH EMS/rescue

- The National Guard tested 1,000 people in Humboldt County for Covid 19.
- Humboldt General Hospital (HGH) covers over 10,000 square miles in Northern Nevada. HGH provides Emergence Medical Service (EMS), hazmat, rope rescue, auto extraction and HGH Para-medicine.
- When dealing with a person with Dementia or Alzheimer's use simple words, give one instruction at a time and provide easy reminders.
- Currently have 3 Dementia patients in the program.
- Residents come from Acute Care/Clinic settings, Emergency room and EMS.

- Patients are followed throughout the integrated healthcare system with services and resources provided to them and the families. Para Medicine allows the patients to stay in their home longer and with family support can maintain a baseline longer.
- When interacting with patients focus on direct conversation, make sure you have an active body language and have patience.
- HGH Para-medicine works with 13 rural hospital that supply the supplies needed to work with the patients, monetary help, and support.
- Patient must have a care plan in place before paramedicine starts. Visits will not be performed in an emergency vehicle but a command vehicle.
- The program was extended past the July 2020 cutoff. With funds from a grant the program can pay for half of a full-time employee.
- Works closely with hospital Social Workers.
- Humboldt County is a Dementia and age friendly community.
- Supported by Nevada Rural Hospitals.
- This program can be replicated in other areas.
- A screening process is in place to keep patients and providers safe during Covid-19.

#### **6. Presentation/Updates from Nevada Senior Services on the Hospital to Home program**

Jeff Klien, FACHE President and CEO, Nevada Senior Services Inc.

- Using funds from a grant the State of Nevada wanted to explore the possibility of a replicable dementia capable program to help people transition from the hospital back into the home and avoid readmissions.
- Rush University Medical in Chicago created a bridge model that was used to create the program.
- Received a three-year grant to help improve resident's life after being in the hospital.
- The 30-day evidence-based program was designed to improve the health outcome of people with dementia and strengthen family caregivers with the navigation of the healthcare system. Making for a better transition between hospital to home and reducing the number of readmissions.
- To qualify the suspicion of cognitive issues must be present.
- Approximately 10 hospitals are participating in the program.
- Helps families get connected with needed area resources that will help them long term.
- 405 cases have been documented since the program started. 326 completed the full 30-day cycle.
- Southern Nevada Medicare has readmission rate is over 35%. Hospital to Home has less than a 1% readmission rate.
- Thinking about Thinking program was created to help hospitals leadership understand the care needs of residents and caretakers of people with dementia.
- Several other resources are available to help caregivers and families navigate dementia care needs.
- With help of Covid 19 funds the program has expanded allowing the addition of 4 respite Social Workers.
- Work is being done to make this program sustainable.
- Three state expressed interest in this program.

#### **7. Presentation/Updates on Dementia Friendly Nevada**

Jennifer Carson, PhD, Director, Dementia Friendly Nevada

- In September of 2016 Aging and Disability Service Division (ADSD) was awarded a grant from The Administration for Community Living (ACL) to launch Dementia Friendly Nevada. Dementia Friendly Nevada does require participation from people and families living with dementia and care partners from 4 relevant sectors of the community.

- OBJECTIVE #1-Initiate community groups across the state to transform the culture of dementia, enabling conversations and participation by all citizens but by most importantly by people living with dementia.
  - 2017 Dementia Friendly Sothern Nevada Urban (Clark County)
  - Age and Dementia Friendly Winnemucca
  - Dementia Friendly Washoe & Elko County's
  - 2018 Pahrump and the Pyramid Lake Paiute Tribe Reservation
  - Teams meet every month, every other month the Statewide Workgroup meets to share resources, problem solve and collaborate ideas.
- Comprehensive needs survey - Dementia Attitude Scale (DAS) was performed by the Sandford Center for Aging.
- OBJECTIVE #2 – Facilitate and mobilize-driven changes utilizing the Dementia Friendly America model.
  - The use of each communities' strengths & gaps was used to help plan their goals and actions.
  - Dementia Friendly Nevada has a comprehensive network in place that was used to coordinate and leverage the emergency response during the Covid 19 pandemic.
  - Each group received startup funds of \$10,000 with decreasing amounts allowing them the opportunity to accept and solicit donations for Dementia Friendly Nevada.
  - The beginning comfort and knowledge of dementia was only a 71%. After 3 years a new DAS survey was performed and the overall knowledge and comfort levels of people living with or dealing with dementia had increased by 9.5% (81%).
- Objective #3 Expand the reach of the programs within the Nevada Dementia Supports Toolbox.
  - 2015 (pre-Dementia Friendly Nevada)194 people recorded to received services
  - 2019- 892% increase 1,924 utilized services.
- Mobilizing Beliefs ethical roadmap can be found on the Dementia Friendly Nevada website, [mobilizing beliefs](#). Was recommended to review as revisions to the recommendations are being made.
- Recommendations in following person first non-stigmatizing language throughout the State Plan.
- Peer support, community awareness, respite support, early diagnosis, care partner education, tribal resources, brain health, active engagements and referrals to community resources are the some of the topics being addressed by Dementia Friendly Nevada and their partners.
- Dementia Friendly Nevada raises awareness threw different programs like Dementia Friends Information Sessions provided via Zoom. Dementia Friendly Southern Nevada Urban developed a community education program (Community Awareness Training) which can be tailored for any sector. Winnemucca has a biweekly Wellness, Art, and Music (WAM) program, among others. Dementia Friendly Nevada Washoe County also has a variety of programs that are volunteer driven like: The Open-Door Café, Dance with Me, and nature walks. Elko County has a Friends Day Out that meets every Friday. A facilitated care partner meeting to share resources. Dementia Friendly Pahrump launched Raising Awareness through Film. Dementia Friendly Pyramid Lake has a Pesa Soaname Advisory Group that works hard in brain health and promotion. In 2019 they held a Tribal Convention that 114 people attended representing 14 different tribes.
- 2020 has brought several challenges for Dementia Friendly Nevada moving interactions to an online Zoom platform, utilizing the Dementia

Friends Education on Zoom as well. Let's Talk About It is available to attend as well.
