- 5. Discussion of the Nevada Assistive Technology Collaborative Programs and Services Supported in Nevada Under the Assistive Technology Act Such as the State Plan, Funding to Community Partners, Planned Activities for 2022 and 2023 and Reports

John Rosenlund, Nevada Assistive Technology Collaborative Director

- Reviewed State plan confirming support of all activities under the act
- Resources assigned through current and existing plan
 - Plans are the services supported historically and currently
 - State level activities, device demonstrations, to allow people to try and compare devices and make informed decisions
 - Device loans for the purpose of making decisions or short term accommodations
 - Under Federal Act, Program is unable to purchase AT directly for people; allowing people to make informed decisions and use AT that has been discarded or being kept in storage
 - Allowed to turn short term accommodations for a limited time period
- Reutilization or open-ended lending
 - Primarily done through CARE chest
 - Raise resources to purchase new equipment
 - Significant statewide effort to receive donated gently used equipment
 - Sanitize it,
 - Repair it
 - Make available to the public
- Care Loan Fund is financial lending program can borrow funding to somebody that qualifies to purchase AT
 - \circ $\;$ Primarily used for home modifications and vehicle modifications
 - Possible on other AT if person qualifies and has sufficient credit
 - \circ $\;$ Typically lending that cannot be done through a bank or a credit union, alternative finance program
- All programs specific to essential daily living with a focus of keeping people living in their communities
 - Being able to get in and out of their homes
 - Receive care to be living in the community versus an institutional setting
- State Leadership Activities fall under training
 - Primarily system changes
 - Assistive Technology resource centers within UNR help facilitate some type of system change, group trainings within-
 - Organizations
 - Agencies
 - Groups of people
 - \circ $\,$ Technical Assistance to help fix policies that may be restrictive in the provision of the assistive technology
 - Information, Assistance, and public awareness
- Funding of \$1.5 million was approved by IFC
 - Funding to be directing focus towards the 12 months 18 months waiting list

- 7. Nevada Medicaid Presentation to Address Questions Established Following the August Item Regarding a Mobility Device User and the Issues that Happened when the Mobility Device Broke. The Following Points were Suggested and Provided to Medicaid:

Jessica Vannucci, Social Service Specialist III, Medical Programs, Hospitals, DMEPOS, Therapy, Audiology; Division of Health Care Financing and Policy

- Jessica Vannucci from Nevada Medicaid, unable to attend presentation but answered the following questions.
 - Identify this is a problem
 - 1. There is a nationwide supply shortage with obtaining all kinds of medical equipment, including wheelchairs especially power chairs requiring computer chips to function
 - 2. Documentation required to have sections completed by the treating physician, therapist, and medical equipment provider
 - 3. Most denials are due to lack of completion of all required documents, such as receipts with the amount to be reimbursed
 - 4. Some providers have manipulated invoices for higher reimbursement and those are referred to the fraud unit
 - 5. Currently in the process of updating Medicaid policies to allow larger timeframes for documents to be submitted as well as simplifying what invoices are needed
 - How can we speed this up? Is there an express program that we can put in line for repairs? So that instead of having a 21-daytime line to process that, can we do it down to 7 days for a repair?
 - 1. Currently only express type area is when someone is being discharged from a hospital and needs life sustaining equipment for their home
 - 2. The state required timeframe for working documentation is found days from any prior authorization received with all needed documentation
 - 3. If all documentation isn't received then a request for additional information is sent and the provider given 5 days to provide the necessary documentation, with an additional 4 day processing time once received
 - 4. If request is denied there are 30 days to request a reconsideration or peer to peer where the treating physician can talk to Medicaid's physician reviewer for clarification
 - \circ $\;$ Clarify who within Medicaid makes AT decisions.
 - 1. Policies within Medicaid are written by Jessica Vannucci but Medicaid has a fiscal agreement gain with technologies that must actually review all documents and complete the medical review
 - How can a consumer advocate on their behalf in that process?
 - 1. Having a transparent relationship with their physician and medical equipment provider helps

- 2. Choosing a medical equipment provider that understands the necessity of operating according to policy and utilizing the telephone numbers on the document to receive any clarity that might be needed
- 3. Medicaid has a district office throughout the State that assists and advocates for recipients
- 4. Recipients can request a hearing after a decision or even contact the Medicaid office prior to a decision
- Discussion, presentation, and Recommendations for 82nd Legislative session (for possible action): Stephen Cohen, Nevada Assistive Technology Council Vice-Chair
 - Discuss BDR #94: 700-hour program.
 - Only current change is opening the program to more physicians to be able to participate in the program
 - Discuss BDR #150: Audio description technology in Nevada State museums.
 - To have audio description technology in all of Nevada State museums
 - Discussion and possible action to appoint an AT Council member as a legislative liaison and/or create a legislative subcommittee.
 - How to navigate when most of the council is connected to federal funding and cannot lobby for state or federal? What are we lobbying for?
 - 1. Members of the council can lobby on their own, separate from representing the council
 - 2. Often requests through HR are denied because of a lack of understanding of the need for the AT
 - 3. Lobbying to make the AT/IL program mandatory, as it is currently optional for ADSD to have, to help avoid possibility of being cut during another budget issue
 - How Does the 700-Hour Program benefit from the AT Council?
 - 1. Consumers usually need assistive technology to adequately work a state job
 - Discussion to request a BDR from ADSD concerning Assistive Technology/Independent Living (AT/IL) program.
 - Would like to see the program assisting with intellectual and development disabilities, then potentially deaf and hard of hearing as well
 - 1. Clarifying that the vocational rehab is part of ADSD rather that stating DSE
 - An opportunity to discuss with people in the community who are disabled?
 - 1. BDR's are due in less than 2 weeks, otherwise are withdrawn
 - 2. DSE doesn't apply to AT but applies to IL instead, IL could be taking steps to address this issue
 - 3. Program and policies are controllable outside of legislature
 - 4. Program is designated to fill a gap in services still has never been filled, causing an 18 month waiting list
 - 5. Program has expanded and created further program extensions such as the autism program within the state of Nevada after legislation provided funding for the ATAP program
- 9. Review and Discussion of proposed AT Bylaw changes (For Possible Action)
 - Stephen Cohen, Nevada Assistive Technology Council Vice-Chair
 - No action to be taken, not 2/3's of Council present
 - Proposed change in article 1 change corporation to organization
 - Proposed change in article 2, section A Change The Office of Disability Services to The Office of Disability Services (name of office that currently implements the AT Act
 - Section B is redundant with the existing subsection D. Proposing to remove it or combine section b and Subsection D
 - Article 3 is missing entirely
 - Article 4, only change would be to update the Office of Disability Services to whichever office is currently implementing the Act

- Existing article 5, would become article 4. Looking for feedback from the DAG regarding membership wording being included
- Article 6, strike language that says after soliciting recommendations from representatives of the organization's representing a broad range of individuals with disabilities and organization with individuals with disabilities. Requesting to put in language that says the council shall establish a process to provide the director with guidance for applicants
 - The council will review using federal guidelines
 - Each member of the council will review the responses and provide responses by the applicant and reply with either support or not support
 - Council's collective responses will be provided along with the response from the applicant to be submitted with the membership application
