- 3. Approval of Minutes of the November 3rd, 2022, meeting: (For Possible Action)

- 4. Review of Council Membership and Pending Applicants
  - No pending applications

- Potential increase to have an additional mandatory position added to the AT Council.
- Discussion of the Nevada Assistive Technology Collaborative Programs and Services Supported in Nevada Under the Assistive Technology Act Such as the State Plan, Funding to Community Partners, Planned Activities for 2023 and Present the Annual Reporting
  - Care Loan Fund is a financial loan that people can apply to get resources to purchase assistive technology. Also known as an alternative finance program
    - Funding came from the Assistive Technology Act
      - Grants from Department of Health and HUMAN Services
        - \$1.3 Million in general funds
      - Care Chest raised funds.
    - Later the project was moved under CARE chest, where it's been for about 20 years.
    - o 11 Care Loan Applications
      - 9 loans were made with a total under \$150,000.
      - 1 loan approved but the client declined.
      - 1 loan rejected.
      - \$15,876 in net loss for loan in default.
    - o 150 open-ended loans were done through the AT Resource Center form the telecommunications program.
    - o 1182 current open-ended loans are in place.
    - 2,818 devices refurbished or repaired at a consumer savings of \$345,844.
      - 981 could only afford through the AT Program.
      - 137 Only available through AT program.
      - 3 System was to complex or wait time to long.
      - Overall performance measure 99.47%.
      - 89.26% Highly Satisfied.
      - Loans by purpose had 29 device trials or evaluation, 4 waiting for repair, 7 short-term, and 4 for conducting training activities for a total of 44 devices.
      - 44 loans equaled 120 devices.
      - 53 number of device demonstrations were performed with 56 participants.
      - 13 referrals were made by outside sources.
      - 3 trainings were reported with 135 topics covered.
      - 300 interactions were captured in the system. 413 interactions through the ATIL program.
      - 1,400 referrals were entered into the system.
- 6. Presentation from CARE Chest about public assistance measures and public awareness activities

- Videos and static spots were aired across multiple platforms for about 6 mo. and ended 1/18/2023.
- Commercials ran on networks of CBS helped cover statewide.
- 100,000 printed documents were distributed as well.
- All platforms combined reached 936,000.
- The campaign cost \$37,000.
- 10 static collateral pieces were produced with 6 different video options as well.
- Referrals increased over the 6 months and approximately 300 residence are receiving help in Southern Nevada.
- 7. Discuss and develop a Position Statement for the AT Council (For possible action):
  - Discussion to review and potentially make changes to the Position Statement with possible revisions oat the next AT meeting.
- 8. Review, Discuss and Approve AT Council Bylaw changes (For Possible Action)
  - The first Bylaw change was to the review process for new memberships.
  - Suggestion in striking out: after soliciting recommendations from representatives of organizations representing a broad range of individuals with disabilities and organizations interested in.
  - Replacing language with: The council shall establish a process to provide the director with guidance for applicants provide the director -- provide the director information that is not in the standardized application. Providing the director with information to best ensure the Nevada assistive technology council is compliant with the act and bylaws and most importantly, have assistive technology user the council use federal guidance and the council's bylaws to establish questions for the applicant to respond. Each member of the council will review the responses provided by the applicant and reply on to either support or not support. Council's collective responses will be provided along with the responses from the applicant to be submitted with the membership application.
  - Steven Cohen moved to accept the changes suggested. David Winik second the motion, all approved.
  - The other changes will be reviewed at the next meeting.
