ADSD Updates

After numerous conversations, including those with the DAG and the DHHS Director's Office, it has become clear the Councils and Commissions cannot do a full administrative process related to recommendations without violating Open Meeting Law. This would include:

- Public Body meeting to conduct comprehensive review,
- Public Workshop, and
- Public Hearing.

Further, since our Councils and Commissions do not have the authority to revise NACs, only make recommendations, it has been decided that each ADSD Council and Commission is exempt from the Executive Order and will not have to conduct Public Workshops, Public Hearings, or submit a report to the Governor's office. There is still an opportunity to make your voice heard and participate in the process.

How To Participate

If a public body wishes to participate in this Executive Order process, they will have the opportunity to: (1) Attend public workshops and public hearings held by state agencies and/or (2) Reviewing, discussing, and approving a letter of recommendations to agencies related to the NAC's to be considered as part of their compliance process.

In order to offer specific recommendations from a public body, the topic must still be included on an agenda as an item for possible action in a formal meeting of the body.
