2. Public Comment:

- Scott announced a successful application for the telecommunication program for the next four years.
 - 1. Provides free telecommunication related equipment for Deaf, hard of hearing and speech impaired.
- 3. For Possible Action: Approval of Minutes of the June 15, 2023, meeting:
 - John motioned to approve.
 - David second
 - Minutes approved unanimously.
- 4. **For Information**: Review of Council Membership, Pending Applicants and Recruitment of Council Membership.
 - > Two applications in review with the Director's Office (DO)
 - > Two applications being processed to be submitted to the DO.
 - > Two referrals we haven't received the completed applications for yet.
- 5. For Information: Open Meeting Law (OML) Training
 - > OML is governed by NRS 241.

- 6. **For Information**: Update Regarding the Aging and Disability Services Division (ADSD) Olmstead Plan:
 - > Provides was in which folks are able to live in the community.
 - > Completed assets, gaps, and critical issues phase of the plan.
 - > Currently working on developing goals, objectives, and strategies for the plan.

- Presentation and Discussion: Updates of the Nevada Assistive Technology Collaborative (NATC) and presentation on Nevada Assistive Technology Resource Center (NATRC) program update:
 - > Presentation was given in April.
 - In the 30 years the program has existed it's always had a waitlist for having resources to purchase assistive technology.
 - Possible \$1.2 million from American Rescue Plan Act (ARPA) to be used towards covering the roughly \$700,000 needed to cover the waitlist.

1. ARPA funds have not yet been released and not yet built into that program.

- Obstacles, other than funding, needed to reduce the waitlist would be:
 - 1. Increase in staff.
 - 2. Find additional vendors.
 - 3. Changes in the way the caseload is operated.
- More programs under NATC and NATRC will be out for proposal over the next four years.
- Assistive Technology for Independent Living Program operates on the State Fiscal year and has already concluded the ongoing partner for the next four years.
 - 1. Services are specific.
 - 2. Not grant funds.
- All services will be listed in the State Plan that was submitted and approved earlier this year.
- NATCR has a long-time partnership with CARE Chest for reutilizing assistive technology.
 - 1. Taking donated items, sanitizing, fixing, and getting durable medical equipment use within the AT Community for those in need.
- For the year the program has:
 - 1. Served roughly 1300 people.
 - 2. Provided about 10,000 devices.
 - a) Typically, between 3,000 and 5,000 devices per year.
- 8. **For Possible Action:** Review, discuss and approve joint letter of support concerning State accessibility audit.
 - Letter directed to individuals broadcasting meetings for legislation through Nevada Electronic Legislative information system (NELIS)
 - 1. Closed caption doesn't work.
 - 2. Recommended to watch through YouTube.
 - Steven to rewrite letter of support to include NRS codes and in coordination with the AT Resource Center.
 - Revised letter of support to be presented later for possible support from the AT Council.
- 9. **For Possible Action:** Review, discuss and approve letter of support for Nevada to pursue a wheelchair right to repair law.
 - Connor Fogal working on a bill to assist AT users in need of repairing and replacing wheelchairs when needed.

- Recommendation to present for Seniors, Veterans and Adults with disabilities to gain more support for the need of legislation.
- > Letter of support for Connor to be brought forward at a future meeting.

10. For Possible Action: Review, Discuss and Approve Nevada AT Council Position Statement.

- For brainstorming purposes need to determine the why of the Position Statement and how the position statement can be used going forward
- Be more specific to technology, rather than a generalization.
- Should include the individual with a disability in the AT decision making process.
- Should educate the AT user and the community.
- > Will have draft position statement for review in following meeting.

11. For Information: Legislative update

- > AB 252: Accessible Museums
 - 1. Will add audio descriptions to museum exhibits throughout the state.
 - 2. Require museums to create an accessible website for people with disabilities.
- > SB 422: Emergency Management
 - 1. Will permit robots to be on Nevada's System of Higher Education (NSHE) campuses to deliver food from Uber Eats, DoorDash, etc.
 - 2. Will have an audible noise that indicates that the robot is nearby for blind and visually impaired persons.

12. For Possible Action: Elect new Vice Chair and volunteers for Olmstead Steering Committee.

- > John Rosenlund volunteered to step in as Vice Chair temporarily until someone else takes over the position.
 - 1. Steven motioned, Chris second.
