 - a. Objective 2.1: Promote and Legislatively Advocate for the Adoption of Policies and Funding Which Delivers Comprehensive Services for Young Children to Ensure Optimal Outcomes.
 - Goal 2.1.1 states "Advocate for immediate eligibility of and connection to comprehensive treatment and services for children based upon a failed ASD screening."
 - Rephrase to have it appropriately state children who are at risk of ASD, based on any ASD screening, to receive services as soon as possible.

- "Advocate for immediate eligibility of and connection to comprehensive treatment and services for children based upon the results of an ASD screening indicating risk for ASD."
- b. Objective 2.2: Promote and Legislatively Advocate for Policies and Funding Which Ensure Effective Education, Supports, and Transition Implementation.
 for School Aged Children.
- c. Objective 2.3: Promote and Legislatively Advocate for Policies and Funding Which Deliver Self-Directed, Person-Centered Services for Adults.
- d. Objective 2.4: Promote and Legislatively Advocate for Policies and Funding Which Adequately Meet the Needs of Individuals with ASD Living in Rural and Frontier Areas of the State.
 - Glossary does not delineate counties that are part of the Frontier Area.
 - Commissioners would like to include Tribal.
 - Commissioner Linda Tran will research true definition of Frontier Area and will be updated for the next meeting.
- e. Objective 2.5: Expand and Integrate Data Systems Among all State Departments and Stakeholders to Track Diagnosis, Treatment, Services, and Outcomes for Individuals Living with ASD to Improve Coordination of Care, and to Disseminate Information.

[Objectives 2.1 - 2.3, Have "Young Children", "School Aged Children", and "Adults" mirror the specific ages stated in the federal guidelines (0-3, 3-21, 21 and over).]

[All objectives will stay consistent to address all ASD individuals and families to effectively meet needs.]

- 6. <u>For Possible Action:</u> Review and Approve the 16 Item Survey* and the Consumer Survey* From the 5-Year Strategic Plan for Circulation to the Public
 - Question 1, add Caregiver to reflect "Parent/Caregiver"
 - This will not only apply just to parents, but also to grandparents, aunts, uncles, etc. who take care of individuals with autism.
 - Delineate age categories on survey.
 - Questions 2 and 3 should have same age groupings.

- Can not be diagnosed with Autism if less than 3 years old.
- Question 5, gender needs to be inclusive.
- Commissioner Linda Tran will edit questions to avoid confusion as to who the survey is about/filling out the survey.
