Anna Marie Binder: Read her public statement out loud.

That says statistics and studies that provide insight into the prevalence of autism. Alcohol syndrome and other neurological disabilities among incarcerated populations. And here's some relevant points. So number one is ASD autism spectrum disorder. A 2012 study estimated that approximately 4% of inmates. In state and federal prisons are on an autism spectrum. This figure may not be fully fully captured. The prevalence as many individuals may undergo undiagnosed or misdiagnosed.

#2 fetal alcohol spectrum disorder.

Of ASD research indicates that individuals with FASD are overrepresented in the criminal justice system.

Some studies suggest that the prevalence of FASD among incarcerated individuals may be as high as 10 to 23%, depending on the population study.

This is significantly higher than the general population #3 was general neurological disabilities, a report from the Bureau of Justice Statistics indicates that a substantial percentage of incarcerated individuals have a form of mental health disorder. While specific statistics for neurological disabilities like ADHD or learning disabilities may not be as readily available.

Studies suggest that individuals with these conditions are at a higher risk of involvement in the criminal justice system and the number four was mental health disorders, which according to NIMH is approximately 64% of individuals in state prisons and 54% federal prisons.

And as you all know, mental health disorders can include a range of neurological and psychological conditions.

So these just highlight the importance of specialized programs within the criminal justice system to address the unique needs of individuals with autism.
