Anna Marie Binder: The CADD Funding and Insurance Subcommittee has met twice. One letter they are working on, was reviewed and two more will be reviewed at the next meeting. Subcommittee members are reviewing Bill Draft Requests and bills that surround funding and insurance. The next letters that will be drafted will be regarding policy and funding.

Corey Nguyen: The CASD Workforce Development Subcommittee has had one meeting. They reviewed each objective to figure out action items. They discussed barriers that practitioners run into when they are trying to enter the workforce whether that be an RBT or a BCABA or BCBA, the state has different things that need to be accomplished in addition to the national certification.

 - AB6: Establishes the Fetal Alcohol Spectrum Disorder Treatment Assistance Program within the Aging and Disability Services Division of the Department of Health and Human Services. This has been addressed, and Anna Marie Binder sent the letter to Abbie Chalupnik and the Commission reviewed it.
 - SB8: An Act Relating to Disability Services; Revising the Categories of Persons Who Receive Certain Services from the Aging and Disability Services Division of the Department of Health and Human Services.

This item was tabled.

• BDR53: Requires School Districts to Coordinate with Certain Providers of Services for Enrolled Pupils with Autism Who Have an Individualized Education Plan (IEP).

Currently, this has not moved over to be a bill. There is no current formal additional text currently. A letter from the Commission is being worked on.

• SB78: Revises Provisions Relating to Boards, Commissions, Councils and Similar Bodies.

Steven Cohen: The LCB Digest portion dealing with this has not been released.

Nicole Muhoberac motioned to table AB6 and SB8 and to revisit BDR53 and for Korri and Nicole to work with Abbie to develop a letter under SB78. Anna Marie Binder seconded. The members voted and the motion carried.
