The Bureau of Vocational Rehabilitation is both a federally and state funded agency which is a part of the Department of Employment, Training, and Rehabilitation.

Their mission is to support Nevadans with documented disabilities in removing barriers to employment through counseling, guidance, training, and other restorative services. They also conduct employer outreach to encourage businesses to create and enhance disability inclusion in their workplaces.

As a Business Account Manager Erica's role is to address misconceptions and unconscious bias about hiring people with disabilities, introduce hiring incentives, reasonable accommodations, facilitate disability awareness workshops, and other recruitment assistance.

The Bureau of Vocational Rehabilitation provides career exploration, work skills hardening, and soft skills to their students between the age of 14 to 21 years old. Eligibility is based on enrollment in secondary or postsecondary institutions and the existence of an IEP or 504 plan.

Individuals with disabilities that are seeking help in obtaining, maintaining, and advancing in employment are encouraged to visit, www.vrnevada.nv.gov to apply for services.
