5. **For Information:** Autism Treatment Assistance Program (ATAP) Updates

- ATAP hired a brand-new position: Psychological Development Counselor
 - Will primarily help with starting the Fetal Alcohol Spectrum Disorder (FASD) pilot initiative (Passed last legislative session; AB422)
- Funding will be used to train staff in the differences between FASD and ASD.
- Working with the Florida Center on evidence-based treatments and approaches and how they differ from a typical ABA for autism.
- ATAP Caseload
 - Average wait time for all ATAP children is 46 days from start date of application to the date the child drops or become active.
- Status of Active Providers
 - Active Children with an ATAP Provider: 815

- Active Children without an ATAP Provider: 210
- Average 100 new referrals a month (January 2023 December 2023)
- BCBA Level Growth
 - Providers currently enrolled with ATAP
 - 282 BCBA's, 23 BCABA's, 9 Consultant Levels
- RBT Level Growth
 - o 1176 RBT's enrolled with ATAP

NEIS presented Autism and MCHAT data for Fiscal Year 24 – July 1, 2023, to September 30, 2023

- Represents children diagnosed with Autism during July 2023 September 2023
- Data was provided to the MA Team from each program as self-reported data.
- 4,589 children served with MCHAT Completion and Diagnosis
 - o 289 (6%) were identified as having an autism diagnosis
- Average age at time of diagnosis is 30 months
