Public comment was provided by a member of the public regarding the investigation into the use of institutions for children with disabilities, which was revealed to have significant financial impacts. The member also introduced recommendations from the Department of Justice (DOJ) regarding intensive home therapy and wrap-around services, which are critical to supporting families and children with autism.

Anna Marie Binder informed the Commission that the state has entered into a 10-year settlement agreement with the DOJ regarding this issue and offered to share more details on the settlement and plans for implementation.

- BDR 62 Expands the jurisdiction of certain specialty courts for juveniles to include children with fetal alcohol syndrome and other neurodevelopmental disorders.
 - BDR 106 Revises Provisions Relating to Autism.
 - BDR 118 Revises provisions relating to autism.
 - AB6: Establishes the Fetal Alcohol Spectrum Disorder Treatment Assistance Program within the Aging and Disability Services Division of the Department of Health and Human Services.
 - SB8: An Act Relating to Disability Services; Revising the Categories of Persons Who Receive Certain Services from the Aging and Disability Services Division of the Department of Health and Human Services.
 - BDR53: Requires School Districts to Coordinate with Certain Providers of Services for Enrolled Pupils with Autism Who Have an Individualized Education Plan (IEP).

- SB78: Revises Provisions Relating to Boards, Commissions, Councils and Similar Bodies.

Anna Marie Binder provided update for the following bills. Korri Ward and Nicole Muhoberac will write a letter in opposition to SB78 for review and voting at next meeting.
