4. **For Information:** Autism Treatment Assistance Program (ATAP) Updates as it Relates to Current Caseload, Caseload Growth, Waitlist Elimination Progress, Referrals, Applied Behavior Analysis Profession Growth in Nevada, and Status of Active Providers.

Samantha Jayme: In April 2025, there were 271 new applications due to increased referrals from the No Wrong Door program through welfare, significantly boosting caseload growth. However, it is still too early to determine how many of these applications will become active cases, especially as processing has slowed due to the influx. By the six-month mark, which began in February, more definitive data on active cases should be available. Currently, there are 11,138 active children with an average age of 8.6 years, while 75 inactive children remain eligible for services at an average age of 6.8 years. The average time on the waitlist is now 45 days, but this is expected to rise due to ongoing referral growth.

The waitlist continues to grow, particularly within Straight ATAP and Service Coordination categories. While Straight ATAP clients wait for funding to access services, Service Coordination clients often need developmental specialist support, though they can receive services via Medicaid without additional funding. Monitoring these trends ensures families are informed about providers available to them. A peak in wait times occurred in February, but hiring additional staff has improved this issue. One vacancy remains in the South for a bilingual developmental specialist, and despite legislative approvals, only one new developmental specialist position has been allocated, maintaining capacity limits. Referrals have steadily climbed since February, coinciding with the No Wrong Door initiative, yet the number of referrals converting to active cases remains unclear. The service breakdown began during COVID-19 to assess funding needs; Service Coordination cases are fully covered by Medicaid, while Straight ATAP cases require external funding. The professional growth within BCBA levels and RBTs has remained stagnant across February, March, and April, after previously showing growth. Among the total caseload, 877 clients have active providers,

while 261 do not. Medicaid leads service coordination categories, followed by insurance assistance.

Efforts to expand provider capacity continue, including outreach to border-state providers who could enroll in Nevada Medicaid. A practicum student aids in developing outreach packets, supported by provider liaisons. The active client breakdown shows 365 children aged 0–5, 482 aged 6–10, 206 aged 11–15, and 85 aged 16–20. Waitlisted children from early intervention services include 42 aged 0–5, 16 aged 6–10, 13 aged 11–15, and 4 aged 16–20. Leadership changes effective June 9 include Rique Robb as Administrator and the promotion of the deputy administrator, who will oversee children's services, early intervention, and long-term care programs.

5. **For Information:** Presentation from Nevada Early Intervention Services on Nevada Early Intervention Services NAC 427 A, Section 8 / NRS 427A.872 Summary Reporting Fiscal Year – July 1, 2023, to June 30, 2024 Randi Humes: At the time of entry assessment, 25% of children were able to independently engage and play with a variety of toys, while 22% were not. This mixed response highlights the variability in developmental abilities among children served. The graphic representation in Graph 3A visually displays the distribution of responses across different developmental domains. On average, children assessed were 29 months old chronologically but had a developmental age of 15 months, indicating a 48% delay at the time of entry.

The exit assessment data provides a comparative look at progress made over time. Across the five developmental domains, there was an increase in the number of children responding positively to assessment questions. One notable improvement was in visual discrimination, where the number of children who could match items increased from 8% at entry to 13% at exit. The graphic presentation in Graph 4A further illustrates these gains, demonstrating overall developmental progress.

At the time of exit, children had an average chronological age of 35 months, with a developmental age of 19 months, reflecting a 45% delay—a slight improvement from the 48% delay at entry. This reduction in developmental delay suggests progress, although challenges remain, especially for older children with autism. As skills become more complex with age, mastery becomes increasingly difficult, impacting the degree of measurable developmental gains.

The report includes data notes outlining exclusions and definitions related to assessment parameters. Some children, particularly those who received fewer than 90 days of service, were excluded from certain reporting requirements. The findings underscore the importance of targeted intervention and continued

support to help children develop skills despite inherent challenges in mastering developmental milestones.

**SB 380/BDR 118:** Senator Ohrenschall sponsored bill. Seeks to provide law enforcement training concerning ASD. Authorizes a certified registered behavior analyst, applying for registration as a registered behavior technician, to engage in the supervised practice of applied behavior analysis under certain conditions. This bill made autism specific training available to law enforcement. Once they pass the National board, RBTs may start working under direct supervision of a BCBA while they wait for their state licensing.

**SB78:** Revises Provisions Relating to Boards, Commissions, Councils and Similar Bodies.

Steven Cohen: Reintroduced as a BDR by the Assembly minority leader.

**SB140/BDR 62:** Expands the jurisdiction of certain specialty courts for juveniles to include children with fetal alcohol syndrome and other neurodevelopmental disorders.

Anna Marie Binder: It is on the Governor's desk.

**SB174/BDR53:** Requires School Districts to Coordinate with Certain Providers of Services for Enrolled Pupils with Autism Who Have an Individualized Education Plan (IEP).

Anna Marie Binder: It has passed both houses, was in Senate Finance last week. The Governor's Council on Developmental Disabilities was able to add amendments. She will send a link to Wendy as well as send it out.

**SB 257/BDR 106:** Senator Dondero Loop sponsored bill. Seeks to provide better diagnostic criteria for ASD.

Anna Marie Binder: This bill was brought forward through the Ackerman Center. She will send it to Korri Ward and Corey Nguyen. Anna Marie Binder motioned for the Commission to draft a support position statement for SB 257 that encompasses their reservations and hesitations, and their request for oversight, so that their children may receive a timely diagnosis that is supported or that is honored by insurance companies. Amy Coyne seconded. Members voted and the motion carried.
