Steven Cohen: Bill 8589: This bill was vetoed.
SB-497: Known as the rate freeze bill.
Bill 589: The only bill that was vetoed among those that would most directly affect the Commission and/or the Early Intervention (EI) community.

Anna Marie Binder motioned to approve the minutes with minor changes.
Meghan Brascia-Burns seconded. The members voted and the motion carried.
4. **For Information and Possible Action:** Review of Letter of Gratitude for Amy Coyne, vote on approval and transmittal of letter to Amy Coyne. Presenter: Corey Nguyen
This item was tabled.
5. **For Information:** Update on CASD Bylaws and public record requirements to post bylaws. Presenter: Autumn Blattman
Autumn Blattman: Asked the Commission members to review the By-Laws that are currently on the website.
This item was tabled until more members can be present.
6. **For Information:** Review and Discuss Legislative Updates Related to the 83rd (2025) Session of the Nevada Legislature. Discuss impact of legislation and budgets on people and families living with Autism Spectrum Disorder.
Presenter: Corey Nguyen and Commissioners

SB 380/BDR 118: Seeks to provide law enforcement training concerning ASD. Authorizes a certified registered behavior analyst, applying for registration as a registered behavior technician, to engage in the supervised practice of applied behavior analysis under certain conditions.

Will go into effect on October 1, 2025.

SB78: Revises Provisions Relating to Boards, Commissions, Councils and Similar Bodies.

Did not pass.

SB140/BDR 62: Expands the jurisdiction of certain specialty courts for juveniles to include children with fetal alcohol syndrome and other neurodevelopmental disorders.

Will go into effect on October 1, 2025

SB174/BDR53: Requires School Districts to Coordinate with Certain Providers of Services for Enrolled Pupils with Autism Who Have an Individualized Education Plan (IEP).

Did not pass. This bill would have required school districts to coordinate with certain providers and services for enrolled pupils with autism who have an IEP.

SB 257/BDR 106: Seeks to provide better diagnostic criteria for ASD.

Affective January 1st of 2026.

Will be effective January 1, 2026. This bill allows children suspected of having ASD to access diagnostic evaluations in a timely manner.

AB6 Establishes the Fetal Alcohol Spectrum Disorder Treatment Assistance Program within the Aging and Disability Services Division of the Department of Health and Human Services.

Signed into law.

AB586 Makes supplemental appropriations to the Aging and Disability Services Division of the Department of Health and Human Services for an unanticipated shortfall related to costs associated with certain provider payments.

Passed and signed into law.

SB8 Revises provisions relating to services provided by the Aging and Disability Services Division of the Department of Health and Human Services.

Passed and signed into law.

SB396 Makes various changes relating to education. Did not pass. The Commission may decide to continue looking at this bill.

Did not pass. This bill will be worked on further in the interim.

Korri Ward is working with state entities to get the survey sent out and to work with the language access Coordinator to translate the survey into Spanish. Anna Marie motioned for the Workforce Subcommittee to move forward with sending out the survey in English and Spanish. Amy Walch seconded. The members voted and the motion carried.
