3. Review and Approval of Biannual COA Funding Recommendations

The commission reviewed the biannual report (See Attachment A)

Ms. Schmidt, Mr. Gold, Mr. Klein, and Ms. Liveratti discussed the following:

- Frozen caseloads and methodology.
- Medicaid budget impacts.
- Encourage legislative leadership including congressional delegates and state legislators to protect home and community-based services.
- Provide specifics and stories to Rosen and Cortez-Masto for support of home and community-based services.

Ms. Schmidt asked if there should be a closing paragraph for concerns for potential budget cuts and impact on home and community-based services and the need to prioritize and maintain, especially amid COVID-19. Mr. Gold added they cannot count on federal funding and must protect the seniors to stay at home, with home and community-based services.

She asked for any comments, suggestions, or edits. She asked to accept a motion to approve the report with adding the growth rate for seniors, changing language from smaller communities take care of their own, and the impact of freezing caseloads.

Mr. Gold moved to approve. Mr. Klein seconded the motion. The motion passed unanimously.

Mr. Klein commended Dena and her team for a great job under a difficult set of circumstances and the hard work to make the package the least painful and most responsive that they can.

Mr. Gold stated to add something in the report that the commission applauds the Aging and Disability Services Division for their hard work to serve Nevadan's.
