- 5. **Presentation, Discussion:** Health Management Associates (HMA) Document Regarding Program for All-Inclusive Care for the Elderly (PACE)
 - Money that was provided from the Americans Rescue Plan Act (ARPA) was used to contract with a vendor to dig deep to establish what services are currently available for the blind and disabled population.

- A report was submitted and can be found on the Division of Health Care Financing and Policy (DHCFP) website.
- The report has recommendations relating to having a better integration for dual special needs plan
- The Division is not taking action to include PACE in the budget as it only services a small number of the population. The focus is on improving services for the greater population to impact as many lives as possible.
- Most resources are currently available without the interdisciplinary structure that PACE would provide.
- Individuals in a PACE program can only see providers within that program so if a favorite physician is not a provider, they are unable to see that provider.
- The gap in benefits is the care coordination piece of the integration.

6. **Presentation and Discussion:** On Medicare Special Needs Plans (SNP)

- The Dual Special Needs Plan (DSNP) allows Medicare Advantage plans to contract with states with Medicaid agencies to assist in the coordination of benefits.
- Currently 9 Medicare Advantage plans service 88,000 individuals with another one to start soon.
- A phase in approach is being reviewed that would allow dual eligible Nevadans to access the DSNP program.
- A potential program expansion to include full benefit duals, Medicare beneficiaries and special low-income benefits is being explored.
- Development of a star rating requirement modeling the federal Medicare program is being considered.
- Exploring ways to expand supplemental benefits that are offered through the DSNP program.
