  - 83rd (2025) Session (state.nv.us)upcoming legislative meetings –
  - Verification of the date is being done members will be updated if it changes.
- 7. **For Possible Action:** Identify, Review and approve support for any Bill Draft Requests that are related to older adult services or the Aging and Disability Services Division. Senate Bill (SB)78 Revises provisions relating to boards, commissions, councils and similar bodies.
  - The bill sponsors will be making an amendment to the bill to leave all boards and commissions with the state agencies they are currently with.
  - Only the licensing boards will go under business and industry.
  - As the bill is currently written, it removes experienced people that currently sit on the COA and decreases the total number of members.
  - Suggestion to have the bill amended to reflect the wishes of the commission members.
  - The revisions suggested were to add the two people with cognitive disorder experience to the current COA structure. Making the Assembly and Senate seats non-voting so they do not affect quorum.
  - The members agreed to leave the appointments being made by the Directors office in the bill.
  - Behavioral Health Day at the Legislature Is February 25<sup>th</sup>, 2025

- Currently there are 174 Assembly Bills, 154 Senate Bills, and 986 Bill Draft Request (BDR)s.
- Molly Walt motioned to have SB78 section 60 amended to add the two voting members with cognitive experience.
- Dorothy Edwards second the motion
- The motion was amended section 60, remove suggested membership, add the current membership of the COA plus 2 members with cognitive experience in the current bill language and keep the governor appointment.

- Older Adults Awareness Day/ Senior Coalition Day falls on April 17, 2025, so the next Subcommittee meeting is being scheduled around that date.
- Waiting for the bill draft to get some sustenance to identify which needs to be followed or give testimony on.

- A. Adult Protective Services Update and Caseload Information
  - Progress is being made statewide vacancies, which is about 30% for social workers, Las Vegas has a higher rate at 52%.
  - Pending several social workers being hired.
  - Recruitment work continues with the University of Nevada Las Vegas (UNLV) and University of Nevada Reno (UNR).
  - Presentations and hosting several social workers students as practicum students to help the vacancies.
  - 728 cases were opened in Decembers. 630 cases
- B. Ombudsman Report
  - Caseload continues to increase, and the cases are more complex.
