*As of 6/30/2020: The data for the period has 96 people waiting for direct services funding, 64 of the cases waiting are over 90 days with the oldest at 260 days. The waiting list dropped as more cases were made active in anticipation of closing out the SFY and getting solutions estimated for the new SFY. There were 5 cases reported as Placed this Month which has prioritized services. The program continues to identify and prioritize consumers with service needs related to prevention of placement OR transition from a care facility. We anticipate the waiting list to continue to rise as the number of new consumers exceeds the number of cases being closed. The waitlist will likely continue to grow unless additional resources for the end services can be increased. The programs Performance Indicators have exceeded targets established with an average of 97% of goals being met.
