- 3. Approval of Meeting Minutes from August 12, 2021 (For Possible Action)

 - Char made the motion to approve, Pam Berek seconded, motion passed with Diane

- 4. Nominations and Election of Chair <u>(For Possible Action)</u>
 Diane Thorkildson, Chair
 - Char made the nomination for Dian Thorkildson to remain chair, Pam Berek seconded, and the vote passed Dian Thorkildson will remain chair for another year.
- 5. Update and Discussion Regarding ADSD Olmstead Plan and Survey Nikki Haag, Public Information Officer, ADSD Cheyenne Pasquale, Chief I, Planning, ADSD
 - Cheyenne Pasquale covered this on Nikki's behalf, we are making efforts to develop a new Olmstead plan as a result there will be a survey sent out to all board and commission members in December.
 - The survey will be used along with older data we have to set the direction for the Olmstead planning process.
 - Our mission is to ensure that older adults and people with disabilities can achieve optimal quality of life in the community of their choice and ADSD will be responsible for promoting its implementation.
 - Development of the plan will most likely take 6 to 12 months.
 - One of the survey questions asks about interest in participating in the committee that will be formed.
- 6. Presentation, Discussion and Make Possible Recommendations Regarding Three Square's strategic initiative related to serving people with disabilities who are also affected by food insecurity. (For Possible Action).

Jodi Tyson, Vice President of Strategic Initiatives Lisa Segler, Director of Strategic Initiatives Sheena Skelton, Registered Dietician

- The team from Three Square was there to do a small focus group as this commission are experts in services for those with disabilities and their families.
- Many families with disabilities are not suited to the traditional model of a food bank and they are looking at ways to better serve those families.
- People who are food insecure are never just food insecure and it's important to get them registered for other wraparound services.
- 35.2 million people in the U.S. including 10 million children, struggle with food insecurity.
- For most the average is seven months of food insecurity but for others with low wages, high cost of housing and chronic health conditions that food insecurity can be consistent.
- According to a national survey a person with a disability is twice as likely to be considered food insecure and four times as likely to experience hunger.
- Three Squares is the food bank in Southern NV and the counterpart in Northern NV is Food Bank of Northern Nevada. The two work very closely together and share best practices and areas of innovation.
- One story was relayed of a client who while food is brought to him, he is not capable of cooking or making the food or making good food choices for himself.
- A more tailored meals approach may need to be taken, there is a program which is the Medicaid physical disability waiver program that uses Medicaid funding to send prepared meals to people's homes. There may be gaps in who is qualified and where the actual need is.
- There is awareness but not talk about families having to turn down better paying job opportunities due to needing more flexibility to care for a child with special health needs and that can lead to food insecurity and holes in the safety net of services.

- There is a need for help with transportation issues that lead to food insecurity.
- One member brought up that the food they see kids receiving through say the school is mostly processed food. The reasoning behind that is many are considered homeless, and they want to provide food that can be easily eaten in the car or desert without a kitchen to prepare it.
- A food bank is a nonprofit organization that distributes food to those in need who have difficulty purchasing enough to avoid hunger.
- The food banks in NV are hubs who work with 180 agencies in the South and 150 agencies in the North to get the food to the people in need.
- You can use the website to find the list of all the emergency food distribution sites, by zip code or through a map because the closest food site might be in a different zip code. They list the dates and times of those distributions and a telephone number to call if you have questions. There is also a call center, and that number is listed, and they can help find the closest food distribution center.
- At the call center they can also provide SNAP application assistance.
- There is also a home delivered grocery program for those over 60 years old called Golden groceries program they can help seniors apply for.
- Another obstacle to getting to the food pantry is the lack of Saturday or evening hours.
- It was suggested that the food bank look at partnering with The Collaboration Center that is pulling together a lot of disability providers in one location.
- Pam Berek has a questionnaire on a website bridgelinkNV.org where a question about food assistance could be added and the people could be directed to the food bank. This questionnaire right now only applies to Northern NV.
- A question was brought up about partnering with RTC and they are running a micro transit program that could open things up for people who qualify on a broader basis than the traditional paratransit. During the pandemic the RTC used paratransit busses and employees to help deliver home delivered meals to seniors.
- SNAP benefits can go a long way towards helping people with food insecurity and reoccurring medical expenses could be waived as income.
- Some of the barriers to SNAP are that it could count as income for other programs and difficulty filling out the application and the time it takes at the office for appointments.
- Many SNAP interviews can now be done over the phone and the food bank can do the application and interview for a disabled person.
- 7. Discussion and Make Recommendations Regarding the Nevada Vocational Rehabilitation 700-Hour Program and How CSPD Can Support and Promote the Program. (For Possible Action)

Diane Thorkildson, Chair

- In the August meeting it was discussed about the commission helping within their individual capacities with social media and getting awareness around the program.
- In 2021, there have been a total of 31 hires, and 15 of those have been released and 7 that have completed their 700 hours and are finishing probation to become permanent employees.
- Half the people were let go before their 700 hours and that makes the program seem unsuccessful it would be interesting to know what strategy Voc Rehab is using to improve outcomes.
- What kinds of disabilities are successful in hiring and what causes them to be let go?
- In Trina's experience the clients most successful where usually ones that had more physical limitation, the ones with developmental disabilities seemed to prefer part time employment which is not offered often by the state.
- As to releases it could be a variety of things such as not a good fit, or health issues.
- A request was made to have more information surrounding those questions for next meeting.

 - We had 3 perspective members to introduce and vote on.
 - Pam Phillips is from Northern NV and has identical twins both with disabilities. She
 believes that Mental illness as a disability is not addressed enough when getting
 services, many times they are denied because Mental illness is not recognized as a
 disability in Northern Nevada.
 - Ilia Sandez is from Southern NV and has a mental disability as well as friends and family members who are disabled.
 - Cindy Swanson is from Southern NV; she is blind and has a son with downs syndrome. She wants to help by being a part of this.
 - Pam Berek made a motion to endorse Pam Phillips, Ilia Sandez, and Cindy Swanson for positions on the CSPD. Char seconded and the motion carried.
