 - Cindy Swanson stated that they spend two days in Carson City advocating for disability awareness day, she believed there were over a hundred people

there advocating the legislature. She wanted to recognize the Nevada Governor's council for doing an excellent job of organizing, helping people understand what happened.

- Diane Thorkildson stated that she was able to go one day and take her daughter who got the opportunity to speak to the senator and see some of the legislative stuff in actions that she has been learning about in her U.S. government class this year.

 - Ilia Sandez made a motion to approve the meeting minutes, Pam Berek seconded, and motion carried.
- 4. Discussion and Update regarding Aging and Disability Service Division (ADSD) Olmstead planning process, No Wrong Door planning process, and Lifespan Respite planning process:

Cheyenne Pasquale, Chief I, Planning, ADSD

- Jeff Duncan presented for Cheyenne Pasquale, starting with the Olmstead planning process.
- S.E.C. is competing their last workshop today at 10:00 am and then they will on key informant interviews finalizing the data gathering for that project. The steering committee is scheduled to meet on March 24th. The plan is expected to be completed by October of 2023 and the website will be updated as we go.
- No wrong door has received a grant and is being revamped from the top down and one of the main components will be mapping the existing access points, as we know, through the Covid pandemic, awareness to service became one of the highest needs. No wrong doors overreaching goal is so that when someone calls for service, they are not told we don't do that call here but work with them where they need to be.
- We currently have three lifespan respite grants at ADSD, the most recent is building a system of support for families of children with diagnosis, this is with the children and family services, and they will help us with the training and gap0s analysis.
- We will be sending out information and a survey to all councils and commissions to help to refocus our efforts, hopefully in the next thirty days.

A. BDR 38-219 SB 43; NRS 427A.032/427A.038

- Changes membership of the Commission on Aging to include officer or employees of city or county government rather than governing body only.
- B. BDR 40-220 SB 4; NRS 439.620
 - Removes requirement that Senior and Disability RX funds must be directly expended by the Department, removes provisions governing direct subsidization of prescription drugs, pharmaceutical and other benefits, increases flexibility in population served, change from quarterly to annual reporting.
 - Jeff presented a PowerPoint slide on the ADSD budget and a highlevel overview of the agency. The PowerPoint is available in the meeting materials.
- Discussion and possible action regarding the formation of a CSPD legislative subcommittee. (For Possible Action) Diane Thorkildson, Chair
 - Stacy asked a question about how this would look, Diane answered that we as a committee would get to see how this looked.
 - Cindi Swanson suggested that we go ahead with the forming of the subcommittee as it could help us get ready for the next session.
 - Diane asked for volunteers and Cindi Swanson stated she would be able to participate but due to issues with Nelis website she could not take the lead, Diane Thorkildson said she could participate but again not take the lead, and Stacy Alaribe said she could participate, it was mentioned that we could possible combine with the SILC legislative committee and Renee Portnell volunteered if our bylaws allow for members of the subcommittee that are not on the main roster of the CSPD. Ilia Sandez said that she could volunteer as well. Dawn Lyons made a comment in chat that stated I (Dawn Lyons) find it duplicative to create another legislative subcommittee for bills relating to people with disabilities. SILC already has one and we could easily coordinate a collaboration.
 - Cindi Swanson made a motion to gather to do an exploratory meeting to see how the different commission can work together in legislative subcommittees. Ilia Sandez seconded the motion, motion carried.
