- Deaf Counseling Center
- Gain information and develop a plan to work with state licensing board on an annual basis to determine the requirements to possibly provide continuing education credits to licensed professionals.
- Coordinate training opportunities with the Deaf Centers of Nevada and other stakeholders to conduct workshops and town halls for the target population.
- Collaborate with Partners in Policy Making program to provide Legislative Training.
- Research and identify a best practice framework to offer family to family and peer mentors.

- The Developmental Disability Council has a paid zoom account they are willing to allow the commission to use to support webinar trainings and other meetings.

- There are a little over 27,000 graduates of this class over the entire United States.

- 60k was approved to provide informational materials to the public on many different topics.
- Accessibility training is provided.
- Rough draft of the healthcare pamphlet should be available next week.
