### 4. Report and Discussion from Director and Chair reports:

Eric Wilcox, Chair

- Cheyenne Pasquale is the acting Interim Deaf Commission Director until a replacement is found to take Khianti Thomas's place.
- Membership updates: Welcome to our newest member Ryan Feldman.
- The position for a person who is an educator remains vacant, an application has been submitted to the Governor's office, but an appointment has not been made.
- The Executive Director position has been submitted to the HR department and is going through the approval process. Once approved the posting will go out nationally.
- New Open meeting Laws allowing virtual meetings if requirements are met.
- September's meeting to be via ZOOM with November's meeting to potentially have two physical locations.
- The Deaf Can workshop has been postponed. Susan Beckett will follow up and schedule a meeting for the Outreach Committee.
- Circle back to the collaboration of partners to discuss deaf rights within the next few weeks.
- Cheyenne will be following up with Sean Maholan to discuss partnerships related to cultural sensitivity trainings for law enforcement.
- Immunize Nevada is working on establishing accessible Covid-19 vaccination clinics for the deaf and hard of hearing.
- Media Letters were sent out to all television networks and the Governor's office with only one response from Nevada News Makers stating they use closed captioning.
- Khianti reached out to the Office of Inclusive Education to urge development of the language benchmark guidelines for parents and educator. No response has been received yet.

## **5. Report, Discussion and Approval of CAS Program updates** (For Possible Action)

Salvatore Fiorentino, CAS Program Director, Aging and Disability Services Division

- Relay Nevada and the collaboration with T-Mobile have done 72 presentations via webinar and will meet the 78 requirements for 2021.
- Television commercials for CapTel have been done and marketed in Nevada.
- Postings on social media have been receiving an increase in traffic/likes.
- T-Mobile is hiring for an open position.
- ADSD has a youth's specialist, adult specialist an assistive technology member and an ASL instructor providing temporary service to the community while our partners get ready to start providing services.
- The transition of services to the new partners is expected to begin October 1, 2021.
- The partners are University of Reno (UNR) - Telecommunications equipment and assistive technology distribution. Nevada Hands and Voices - access to services funding for children up to the age of 21. Nevada Care Connection - access to services funding for adults over 21. Nevada Hands and Voices - partial funding for language acquisition to fund deaf guide programs. Applications for ASL instruction are still being reviewed.

- CAS has begun evaluating language acquisition services and the role in Nevada of Early Intervention Services and the Department of Education.
- State interpreters are still providing services for the Governor's press conferences along with mentoring services throughout the State of Nevada.
- Mentoring services are provided to Nevada residence that need to focus on immediately developing their skills. Two of the three applicants on the wait list have been enrolled into the program.

- One workshop was done in May and recently one was done introducing new training collaboration processes that will allow them to practice their skills.
- This month's training is part two of the workshop smooth talk which is interpreting from ASL to English. 69 participants have enrolled in the class and the next two sessions are completely full.
- Senate Bill (SB) 179 passed in the recent Legislative session and changes are effective July 1, 2021.
- Those who do not meet the new requirements have provisional opportunities until July 2026 to be able to advance their skills and stay on the registry.

- This State plan will focus more on policies and programming instead of direct services
- The original State Plan was drafted as a 5-year plan, a recommendation has been made to change it to a 2-year plan that would coincide with the work and advocacy that is done with state agencies and legislature which helps drive the interim session priorities.
- Recommendation to hold a public meeting to get community feedback and make edits accordingly and have it on Septembers Agenda for Approval.
- If a Recommendation has not been accomplished in a two-year time frame it would stay on as a Recommendation.
- If a Recommendation has been met, then it would go into an Appendix as retired.
- A suggested was made to leave the top level of the goals or structure of the Strategic Plan and make the changes to the objectives or task that are under the goals.
- Commission consensus is a desire to keep a 5-year plan but have set legislative priorities.
- Summer Wright, Eric Wilcox, Laura Fink & Susan Beckett volunteered to form subcommittee to seek public feedback.
