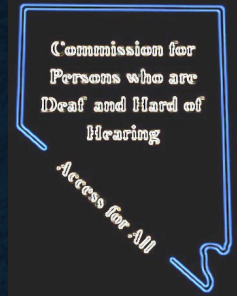

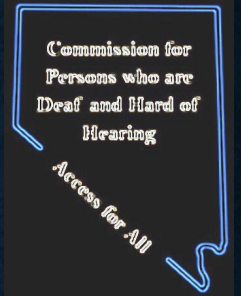

NRS 427A.750 Members...

(a) **Sandra LaPalm, Commissioner – Rural**

One nonvoting member who is employed by the State and who participates in the administration of the programs of this State that provide services to persons who are deaf, hard of hearing or speech impaired;

(b) **Vacant**

One member who is a member of the Nevada Association of the Deaf, or, if it ceases to exist, one member who represents an organization which has a membership of persons who are deaf, hard of hearing or speech-impaired;

(c) **Maureen Fradianni, Commissioner – North**

One member who has experience with and knowledge of services for persons who are deaf, hard of hearing or speech-impaired;

(d) **Rusty Shaffer, Commissioner – North**

One nonvoting member who is the Executive Director of the Nevada Telecommunications Association or, in the event of its dissolution, who represents the telecommunications industry;

One member who is a user of telecommunications relay services or the services of persons engaged in the practice of sign language interpreting or the practice of realtime captioning;
