- 3. Discussion of Historical Creation of the Communication Accessibility Committee: (Informational)

- This is a brand-new subcommittee of the Nevada Commission for Persons who are Deaf and Hard of Hearing. The subcommittee was created in response to the needs outlined in the Strategic Plan. So far there are two members Susan Beckett, the chair and Laura Fink the vice-chair, one of these inaugural meeting's agenda items is to populate the rest of the committee.
- 4. Discussion and Approval of Communication Accessibility Committee Goals and Needs Based on Strategic Plan: (For Possible Action)

Susan Beckett, Chair

- The first recommendation in the strategic plan is inclusion of the community and once we get a director on of the communication accessibility benchmarks would be inclusion in the community. We would assist the director as needed in that first recommendation.
- The second recommendation is government accessibility and one place we can look at is DETR unemployment is still having issues with access for deaf and hard of hearing individuals. It is suggested that the accessibility subcommittee drafts a letter to the unemployment division and take that to the Commission for approval
- In addition, with the legislative interim session committees getting started, it has been an area with a consistent challenge in accessibility of meetings. The legislature does have a new webpage that describes their current effort to ensure accessibility. Suggestion is to look at that information and determine if there are any recommendations that we need to make to the legislature, which would then be taken to the full commission for approval.
- All state contracts for ASL and CART services have expired and that means that right now no state agency can request interpreter services. We would like to make a recommendation to the full commission that there needs to be a change, there cannot be a drop in access to accommodations, ever.
- The third recommendation is quality interpreters, and we have down handle as needed and not having access is an urgent need to be addressed.
- The fourth recommendation is emergency response and management. Communication accessibly benchmarks would be partnerships with emergency response groups and entities, training, ideas, and updates of policies and procedures to include target populations.
- The fifth recommendation is healthcare access, communication accessibility benchmarks would include partnerships with healthcare workers with the director, training, ideas and updates of policies and procedures to include target populations.
- The sixth recommendation is language development, and it is felt that this needs to be handled mostly by the education committee more so than the accessibility committee.
- The seventh recommendation is postsecondary education and again this is more of an education committee issue.

- The eighth recommendation is WIOA partnerships and communication accessibility benchmarks we handle those issues as they arrive and work with the director and the education committee.
- Laura Fink made a motion to submit these recommendations and goals to the full commission for approval, Susan seconded, and motion passed.
