 - Pipeline Issues: Access to accredited Interpreter programs and Interpreter based Education in the North Updates and Community Feedback.

- 5. Executive Director Directives and Subcommittee Maintenance Needs. Obioma Officer, Executive Director
 - Welcome Ehren Dei, Vice president of NVRID as the new NVRID Representative
 - Thank you for being a part of our committee as we work to improve our state.
 - Ehren introduced himself and shared his background with us.
 - Added seat for BIPOC Representative, seat now available
 - We are currently recruiting for our BIPOC representative seat now, if you know of anyone, please have them contact us so we can start the process.

- Current proposed Recommendations: (For Possible Action)
 - Recommended solution for lack of access to accredited Interpreter Programs and Interpreter Based Education in the North through collaborations with Southern Interpreter Programs remotely (i.e., CSN, NSC, etc.)
 - Last meeting, we talked with David Kelsey about a program at TMCC, and doing a collaboration with Reno to get a program up North. Another solution might be to have CSN and NSC work together and maybe get a remote summer program going to start.
 - It was announced at the last NVRID meeting that UNR, University of Nevada, Reno, would be starting an ASL minor in the fall of 2023 and hopefully in 2024 they would be starting an interpreter training program.
 - Recommended solution for previous community concern Registry restrictions and Fear of consequences for not meeting higher education requirements by requesting implementation of an alternative pathway. Make allowance for programs like CAS's Mentor program or hours accrued in services satisfy Education Requirement.
 - Aliana Duncan made a motion to satisfy the higher education requirement or to use an alternative pathway, an education program such as the CAS mentoring program or hours

accrued during professional development to satisfy the higher education requirement, Dolores Parish seconded, and motion passed.

- 7. Discussion and Approval of any Recommendations related to Interpreter subcommittee Goals and Needs based on the Strategic Plan: (For Possible Action)

- Recommendation #2 –Government Accessibility
 - Right now, our government is not providing interpreters for broadcasting, for lots of areas, and we've not been able to get that need met. What can we do to support interpreters, so they are ready and prepared for government work? One idea would be to suggest workshops specifically for government topics or issues, vocabulary, etc.
 - There was discussion of the CAS program and maybe adding a specific government-related topics portion to that.
- Recommendation #3 –Quality Interpreters
 - If we had a specific group or class or workshop, something to make interpreters feel more comfortable in specialty areas that would help them be more comfortable in their interpreting and their quality in specialty areas. We need better programs than what we have in the colleges right now.
 - As a committee look at developing a system for certification or screening on a state level to build the confidence in new interpreters, that is more general, applied to developing community skills etc. Even interpreters that have been working for a while but are not nationally certified could be involved in this system.
