 - Dr. David Kelsey had some concerns about the laws relating to interpreters in the state of NV 656 A specifically, there are two different concerns, there is an assessment that you can take as an interpreter called an EIPA, that focuses on interpreters that work in K-12 settings. Then we have a national certification called NIC, given by RID, this is a generalist certification. And the K-12 doesn't cover any of the generalist situations it's a hundred percent different in the way it assesses interpreters. The law we have now in my opinion, mixes the two together, and I feel that if you have a K-12 interpreter who has an EIPA they should be in that setting but not over in a community setting because that's now what they are trained to do.

- BDRs currently supported by the Commission and up for Proposal to the Legislature
 - i. Discussion and Updates on AB165 which makes various Changes to state-issued identification, submitted 8/1/2022.
 - a. This is BDR165 not AB165 the clarification is that it has not become an assembly bill yet and has not been assigned to a committee in the legislator.
 - b. Susan Beckett reached out to Shannon Billbray-Axlerod and talked to her about concerns the public had brought up dealing with the police and the solution they came up with is to work with the Department of Motor Vehicles and add a capital D for Deaf individuals, capitals HH for hard of hearing and capitals SI for speech impaired to their automobile registration so that emergency personal would have that information upon approaching a vehicle and it could alleviate some of the communication issues.
 - ii. Discussion and Updates on AB563 which revises provisions governing services to persons with disabilities, submitted 12/05/2022.
 - a. This is BDR563 not AB563 the clarification is that it has not become an assembly bill yet and has not been assigned to a committee in the legislator.
 - b. This BDR came out of conversation on how to make the commission better, more aware of the community and we realized we were missing a seat for an interpreter or someone very familiar with interpreter laws. Eli brought this to assemblywoman Tracy Brown-May and she let him know that there was a BDR for us and while Eli was traveling in Egypt, Obioma and Steven Cohen worked on the verbiage for the BDR.
 - iii. Discussion and Updates on SB43 which makes various changes relating to services for aging persons and persons with disabilities (BDR 38-219).
 - a. This is a clean-up of NRS 427A, the cleanup language is broadening the purpose of the state plan for persons who are Deaf, hard of hearing or speech impaired which is in line with eh efforts that the commission has already undertaken in their state plan.
 - b. The commission could recommend amendments to this Senate Bill as part of the clean-up process.
