2. Public Comment:

- Public comment from Shelly Freed addressing no televised ASL interpreters during the State of the State address was read, the public comment is included with the meeting materials.
- Susan Beckett and Beth Jones made a public comment at the Senate Health and Human Services Committee for Senate Bill (SB) 43. Requesting to extend the State Plan to a five-year plan.
- Online video was available to connect with cell phones, but the connections between the video and relay were off making following the meeting difficult.
- Public Comment from Eric Wilcox as a private individual not as a member of the commission or a representative of any agency addressing the restrictive Grant qualifications and the lack of resources. This public comment can be found with the meeting materials.

3. Approval of Minutes of the November 16, 2022, meeting: (For Possible Action)

- Eli Schwartz made the motion to approve the November 16, 2022, minutes, Maureen Fradianni second the motion, all approved.
4. Presentation, Global Technology Communications (GTC) – ASL Anywhere Grant:
 Patty Kuglitsch, Account Manager - Nevada
 Benjamin Soukup, Chief Executive Officer
- Will provide training for the ASL Anywhere app and its benefits.
 - Collaboration with the Commission, service providers and policy makers
 - Trial packages and monitoring to assess sign language needs are being offered to Nevada Care Connection (NCC) and the Department of Employment, Training and Rehabilitation (DETR) and Rehabilitation-Bureau of Vocational Services (BVR).
 - Data collected will help determine benefits and barriers.
 - Several outreaches over several platforms were done in the last quarter of 2022.
 - GTC is looking at ways they can provide training to consumers.
 - Early feedback is positive and request for increase in allowed time.
 - ASL Anywhere app can be added on devices under equipment distribution programs.
5. Report, Communication Access Services (CAS):
 Jennifer Montoya, Communication Access Services Program Director
- Jennifer Montoya is now the Communication Access Services Program Director.
 - A candidate has been offered the positions of the CAS Program Manager and if they accept will be on board soon. The positions primary focus will be on the interpreter registry rules, responsibilities, functioning and coordinating and maintain the data base.
 - Andy Firth is the new Relay Administrator of Nevada and will be providing the Commission with updates.
 - T-Mobile's current contract ends June 30, 2023, and the new 5-year proposal is being assembled.
 - T-Mobile does not provide Captioned Telephone Services (CTP), but subcontracts with Hamilton.
 - A competitive Notice of Funding Opportunity will be released in February 2023. It will be for telecommunication equipment distribution, language acquisition and American Sign Language (ASL) instruction.
 - A Commission member will be selected to be on the Notice of Funding Opportunity (NOFO) panel.
 - The Mentoring Program is still providing one on one mentoring and hosting training workshops monthly.
6. Presentation, Northern ITP Program, and requests for Grant Letter of Support for ITP Program:
 Andrea D Juillerat-Olvera, DRC Training Specialist/Staff Sign Language Interpreter/Instructor
- The ASL classes are now under the World Language department and are acceptable of the ITP program.
 - Offices have been set up and teachers that are hard of hearing have been hired.
 - The Northern area need this program to help with the lack of interpreters in the area, lack of ADA compliance, having adequate support to name a few.
 - A collaboration with the deaf community to help develop a training program that will bring teacher to the area.
 - The first step is to set up a minor in ASL Deaf Studies.
 - Currently have 60 ASL level 4 students with 8 more on a waiting list.
 - Level 5 is expected to start in the fall of 2023.
 - Expectation that 25-30 students will register for the ASL Minor Studies for phase 1.
 - See presentation for program breakdown of the expected \$36,823.50 first year cost.
