5. Community Concern Topic(s) to be presented to the Full Commission for Support Approval: (For Possible Action)
- a) Updates and Discussion on Nevada State College (NSC) representative's offer to provide ally opportunities between the Southern Program and the Northern need through remote access:
- Dr. David Kelsey, Ed. D, Lecturer, Deaf Studies
- NSC works with Truckee Meadows Community College (TMCC).
 - TMCC is an online class only college that has ASL study classes but no interpreter classes.
 - Western Nevada College has interpreter certification classes and offer interpreting 4 and 5.
- b) Data and Letter of Support Request for Interpreter Program Grant for the New Northern ASL program at the University of Reno (UNR):
- Andrea Juillerat-Olvera, DRC Training Specialist/Staff Sign Language Interpreter/Instructor
- Andrea is leading the effort to establish an interpreting program in Northern Nevada.
 - There are three parts that she is working on currently and they are, writing a grant for the Deaf TA's, teaching assistants, et cetera, the deaf tutors, second recruiting Deaf advisors to help us establish a program design and third, development of a Deaf video library.
 - The program is supposed to start in the fall of 2023, and we have teachers, but the three goals are an additional aspect of our program that we are trying to get grant funding for.
 - They have recruited one instructor Cal Adair and phase one will be offering a minor in ASL Deaf Studies, with an immersive experience that is still being worked on.
 - The minor program will start with ASL 4 and ASL 1, 2 and 3 will still be offered as well but not part of the minor program. The class catalog for the University is looking to be published the last week of March and we can start advertising the program then.
 - What Andrea is looking for is a letter of support from the commission, Alina Duncan made a motion to write a letter of support, something, that we as a subcommittee agree to bring this issue to the attention of the full commission. Sara Sain-Jurgens seconded the motion, motion carried. Obioma did clarify that we will write the letter and then have the subcommittee approve the letter, then we will take it to the full commission. Aliana will write the letter and send it to Obioma to send out to the rest of the subcommittee members, so we don't violate open meeting law.
6. Executive Directors Directive(s) and Maintenance Need(s): Community Partner Introduction and Presentation on National Association of Interpreters in Education (NAIE)

- The NAIE was established in 2016 and our goal is to provide equal access for education for Deaf, hard of hearing, or Deaf and blind. They do this by providing resources and networking.
 - The NAIE online, has all 50 states and what's required of them, all states are different in their requirements. NAIE has a code of ethics due to working with kids and being mandatory reporters.

- If you're a member of NAIE, they have monthly free workshops that are recorded and provide CEU's for continuing education. The two levels of membership are \$60 for interpreters and \$30 for college students, that is a yearly fee.

- Recommendation #2 –Government Accessibility
 - An example of what is needed is that during a recent general committee discussion of the legislature there was an interpreter in the room but when the discussion started the interpreter wasn't available on camera. What we want to do is educate them to have the interpreter accessible to all. How do we do that?
 - A possible solution is to create a document that can help people understand what to do when working with an interpreter or the Deaf community. Dolores has access to an already created document that has samples of questions to ask and samples of what the streaming should look like, hybrid, if it's on stage, all these different situations, what they should look like.
 - Dolores Parish made a motion to create a document with technical information for audio/visual consumption for makers, utilizers, people in government or in meetings who use these resources that we can provide this document as a suggested technical advice. Sara Sain-Jurgens seconded the motion, motion carried. Dolores will take the lead in creating the document by the next meeting.
 - Recommendation #3 –Quality Interpreters

 - Ehren Dei asked Andrea a question about the library and if that was going to start in 2023 with that minor?
 - Andrea answered if we get the money from the humanities, then we can start the advertisement for that with a list of topics that we're willing to accept. Then we will set that up for the interviews for Deaf people and let them know the requirements etc. and start filming people.
