# Communication Access Services – Program Report – 2/8/2023

Commission for Persons who are Deaf and Hard of Hearing

### **Relay Nevada**

The CAS Program hired Andy Firth as the new Relay Administrator for Nevada. He and the team have been working on bids submitted on our Request for Proposal for the next five-year certification period, 2023-2028. T-Mobile's current contract ends June 30, 2023. T-Mobile is no longer providing Captioned Telephone Services (CTS) but they have subcontracted with Hamilton for those services to continue. Hamilton is now the only vendor certified to provide analog (PSTN) CTS. Analog CTS is captioned phone services through a landline, and not through the internet. ADSD has been working directly with Hamilton and state procurement officials to continue analog CTS services via an individual contract for these services with Hamilton.

Relay Nevada submitted its application for certification of its state TRS program to the FCC for the next five-year certification period and is awaiting a decision on that application.

Andy has been finalizing the plan for migration of analog (PSTN) relay users to IP-based relay services, including IP-CTS. CAS anticipates beginning its outreach campaign to encourage CapTel and TTY users to upgrade to broadband services and equipment in mid-February. This plan is in response to the FCC's stated intent to eventually "sunset" requirements for analog relay services within the next three to five years. CAS is collaborating with the Nevada Telecommunications Equipment Distribution Program (NTEDP) and the Nevada Office of Science, Innovation and Technology (OSIT) ("Broadband Office") to achieve a goal of 100% broadband relay in Nevada within three years. Outreach materials are being developed with information regarding broadband discounts and equipment upgrades. Andy will be traveling statewide this year to distribute this information and educate Relay Nevada users on the benefits of upgrading from analog to digital technology.

### **Communication Access Service Centers**

The Aging and Disability Services Division (ADSD) will be releasing a Notice of Funding Opportunity (NOFO) in the beginning of February 2023 for these services: telecommunication equipment distribution, language acquisition, and American Sign Language (ASL) instruction.

A public hearing for the new regulation to NAC 656A was held on August 30, 2022 to inform the community of the new changes. The regulation was filed with the Secretary of the State on September 28, 2022 and then sent over to the State Library and Archives. Three Q & A sessions were held in November 2022 to explain more about the changes and timelines as well as to give the opportunity for individuals to ask questions. These attendances were deaf and hearing consumers, parents of deaf children, businesses and school districts who hire interpreters and interpreters.
