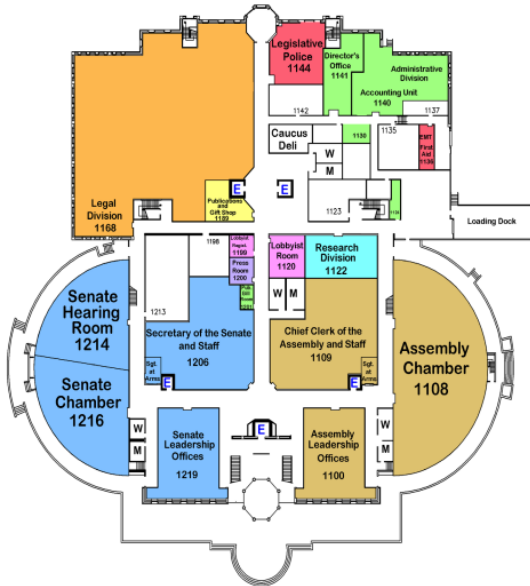

FIRST FLOOR

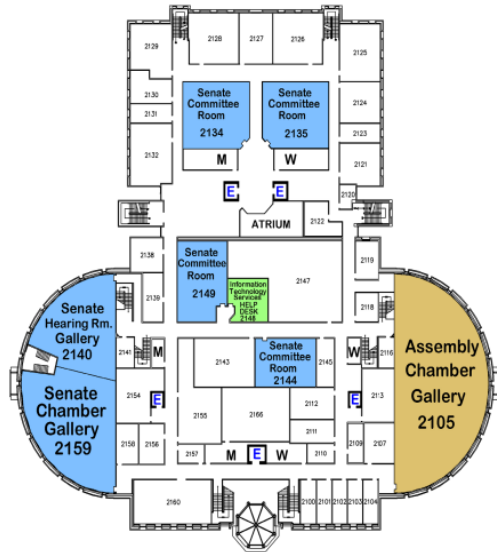


Carson Street - Highway 395

SECOND FLOOR

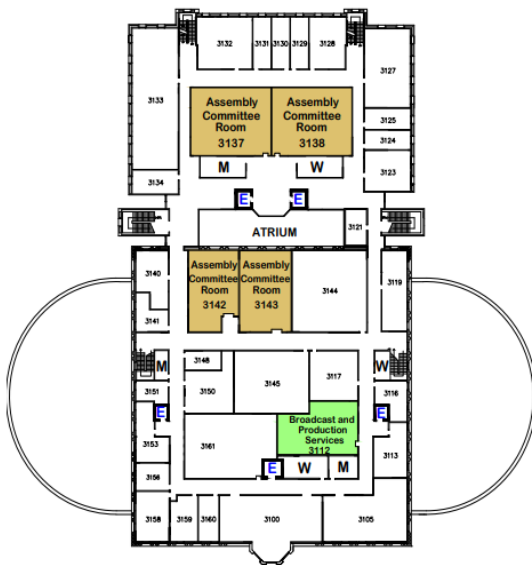

THIRD FLOOR

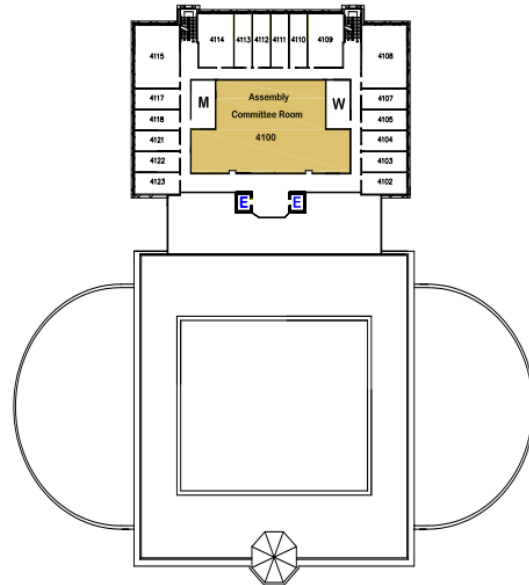
