

- Senate Bill 98 Revises provisions relating to education.
- Senate Bill 315 Revises provisions relating to persons with disabilities.
- Assembly Bill (AB) 161 Revises provisions governing drivers' licenses.
- Assembly Bill 202 Revises provisions governing certain practices in certain healthcare facilities.
- Assembly Bill 206 Revises provisions governing services to persons with disabilities.
- Assembly Bill 255 Revises provisions governing the support of children with special needs. (This one is a maybe)
- Assembly Bill 259 Revises provisions governing people with disabilities. (This one is a maybe)
- Assembly Bill 331 Revises provisions governing court interpreters and translators (this bill died in legislature, and we want to look at bringing it back next session.)
- Senate Bill 287 Revises provisions relating to the Nevada ABLE Savings Program (this bill died in legislature, and we want to look at bringing it back next session.)
- Senate Bill 373 Revises provisions relating to language access. (This bill died in legislature, and we want to look at bringing it back next session.)
