3. **For Possible Action:** Approval of Minutes of the January 17, 2024, meeting.

- We would like to make an adjustment to the minutes for the previous minutes as the DD council does not have a set amount of funding for Deaf Day at the legislature and we would like to withdraw the statement about funding.
- Beth Jones made a motion to approve the minutes with the adjustment from the above statement, Catherine Nielsen seconded, motion carried.

4. **For Possible Action:** Commission Directive Topic(s): For Discussion and approval to bring to the Commission for final approval if needed.

- a) Planning and Discussion and approval of recommendations for Deaf Day at the Legislature 2025, collaboration with Las Vegas Deaf Seniors.
- It was decided that 3 members of the subcommittee, Beth Jones, Susan Beckett, and Catherine Nielsen will work with at least 3 volunteers from the Las Vegas Deaf Seniors to plan Deaf Day at the Legislature 2025 and bring that information back to the subcommittee.
- b) Discussion and Approval of Recommendations for new Bill Draft Requests (BDR's) needed in the next legislative session. From Eli's list of possible BDR's to include Advocacy Concepts, BDR's to be solicited by Commissioners direct connections.
- As we are in the interim and committees are doing a lot of presentations at this time to educate the legislators this would be a perfect time for us to capitalize on that and do presentations in as many settings as possible.
  - It was suggested that we as a subcommittee and commission come up with position statements that we can use when testifying and communicating with the legislature and then we do not have to vote each time there is an opportunity to voice the commissions support of a legislative initiative.
  - This discussion was very robust, and it was decided to continue the discussion into the next meeting.
- c) Discussion and Advocacy concepts to address current challenges with statewide noncompliance with Americans with Disabilities Act (ADA)/Individuals with Disabilities Education Act (IDEA) Federal Laws.
- This item got included in the discussion of BDR's.
- d) Advocate for detention centers to be ADA compliant by utilizing ASL interpreters and communication access.
- We received information on this that the Nevada Disability Advocacy and Law Center's role is protection and advocacy, to go into facilities to investigate, usually unannounced. Catherine Nielson is president of their board and can submit a complaint to them and have the facilities in question investigated.
- e) Advocate for a Deaf school for kindergarten – 12<sup>th</sup> grade.
- This item was tabled until the next meeting.

  - Position statements for the commission.
  - Bluetooth/T-coil for government building.
  - Go over Eli's list and advocate for a Deaf School.

  - Possible educational presentations to legislative subcommittees.
