1. **Roll Call and Opening Statement:**

2. **Public Comment:**

- Autumn Blattman introduced Hodan Edan, a new staff member who will work under Wendy Thornley and assist with Commission tasks.
- Obioma Officer reminded attendees about the upcoming Engagement Conference scheduled for December 13–14: 175 people registered so far; capacity is 250.
- Encouraged registration and shared a link in the chat.

Lorraine Belt-Dolan, Chair

Discussion

- Paula Korowitz expressed uncertainty about the details of the June meeting.
- Autumn Blattman noted a correction: the membership list in the minutes should reflect current members (Lorraine and Paula).
- Lorraine Belt-Dolan clarified that previous members listed were in good standing through August and explained reinstatement history for Paula and herself.
- Technical difficulties occurred while attempting to share the screen to review the minutes, but clarification was provided verbally.

Action Taken

- Lorraine Belt-Dolan made a motion to approve the June 20, 2025, meeting minutes.
- Paula Korowitz seconded the motion.
- Vote: Motion passed unanimously.
- Outcome: June 20, 2025, meeting minutes approved.

4. **For Possible Action:** Discussion and possible approval of October 3, 2025, Accessibility Subcommittee meeting minutes

Discussion

- Lorraine Belt-Dolan noted there were questions regarding the October 3, 2025, meeting minutes.
- Due to these questions, the committee decided not to proceed with approval during this meeting.

Action Taken

- Item was tabled for review and discussion at a future meeting.
- Outcome: No vote taken; approval of October 3, 2025, meeting minutes postponed.

5. **For Information Only:** Introduction to newly appointed and/or reappointed Accessibility Subcommittee members: Jaime Vitale (new member) and Lee Bullock (reappointment)

Discussion

- Lorraine Belt-Dolan introduced Jaime Vitale as a newly appointed member and Lee Bullock as a reappointed member of the Accessibility Subcommittee.
- Both Jaime and Lee confirmed their willingness to serve on the committee and work collaboratively as part of the subcommittee.
- Lorraine clarified that no formal motion was required since appointments had already been approved; this agenda item served as an introduction.

Outcome

- Jaime Vitale and Lee Bullock were officially recognized as members of the Accessibility Subcommittee.
- Subcommittee now has full membership and is considered official.

5. **For Possible Action:** Approval of tentative agenda items for the next meeting

Discussion

- Lorraine Belt-Dolan asked for suggestions for the next meeting's agenda.
- Proposed topics included:
 - Access to services for DeafBlind individuals in Nevada.
 - Feedback from the Engagement Conference (Dec 13–14), including DeafBlind participation.
 - Town Hall feedback on accessibility issues (e.g., DMV interpreter availability and agency preparedness).
 - Brainstorming strategies to support community providers in serving Deaf, Hard of Hearing, and DeafBlind individuals.
 - Obioma Officer emphasized reviewing community feedback from both the engagement conference and town hall.
- Lorraine confirmed these items would form a robust agenda and noted adjustments could be made if needed.

Action Taken

- Committee agreed to include the proposed topics as tentative agenda items for the next meeting.
- Outcome: Tentative agenda items approved for the next meeting scheduled for March 13, 2026, (pending Commission calendar approval).

6. **Public Comment:**

Jaime Vitale shared:

- Gala tickets are running out; encouraged attendees to purchase soon.

- Donations requested for Nevada Hands & Voices holiday toy drive:
- Collecting unwrapped toys for children aged infant to 17.
