6. **For Information Only:** Review current feedback pertaining to Deaf and Hard of Hearing services, resources and advocacy from the Townhalls held in Elko, Reno and Las Vegas.

Obioma reported on a town hall tour conducted throughout the state in October 2024. Feedback was gathered from many community members, documented by the commissioners. In Elko, six community members participated, and the commissioners noted 22 different impressions or observations. The main concern raised in Elko was healthcare accessibility in rural areas, particularly for children's speech therapy and audiology services. There are significant challenges in accessing healthcare services in Elko due to a shortage of providers and long travel times. Providers within a two-hour radius are often fully booked. The size of the Deaf community in Elko is currently unknown, but this issue has been ongoing for years. While some improvements have been made with early intervention equipment, many services still require face-to-face interaction, which families prefer.

Another major concern is the shortage of qualified interpreters, both hearing and Deaf, particularly in rural areas. This issue is seen nationwide and affects schools and education. In Reno, the primary concerns are ADA compliance and cultural competency, with a significant gap in awareness and training regarding these issues.

Funding for training is lacking, but there are efforts to network and partner with organizations to provide professional training. A summit is being planned to discuss these issues further. In Las Vegas, there are gaps in healthcare access, ADA compliance, and interpreter availability, with an overproduction of educational interpreters and a shortage of community interpreters.

Overall, there is a national shortage of interpreters, and ongoing efforts are needed to address these challenges through policy development and community engagement.

7. **For Possible Action:** For Review, Discussion, and Possible Action: Examine and assess assignments related to enhancing accessibility in government and medical settings, as outlined in the State Plan requiring potential legislative attention and commission approval.
