Jaime Vitale motioned to table this item. Carol Helou seconded. Members voted and the motion carried.

4. **For Possible Action:** Discussion and Possible Vote to Approve recommended revisions about the Interpreter Registry's minimum credential requirements set forth by [NRS 656A](#) and [NAC 656A](#). Focus is regarding grievance process, EIPA

services, and Community Interpreter services and updates to better align with national standard practices. The Deaf and Hard of Hearing community is encouraged to join this meeting to explain what is happening in service provisions for K-12 and Community settings/outreach.

Discussion

- Committee reviewed current interpreter credential requirements and identified gaps compared to national standards (RID, EIPA).

Concerns raised about:

- Grievance process: Nevada law limits grievance filing to Deaf consumers, conflicting with RID's broader accountability standards.
- EIPA services: Educational interpreters restricted from medical/legal interpreting unless meeting EIPA 4.0.
- Community interpreting: Need for clearer boundaries and specialized tracks (K-12 vs. community).

Suggestions included:

- Separate registries for K-12 and community interpreters.
- Role-play workshops and Deaf-centered education on grievance filing.
- Research RID and Nevada Registry standards for alignment.

Public Input:

- Deaf community members expressed frustration with underqualified interpreters in medical settings.
- Recommendations for culturally appropriate feedback systems (e.g., surveys, QR codes, outreach at Deaf events).

"I move to research RID standards and Nevada state law to find areas of

alignment and make recommendations for changes to the Nevada state law.”
