Eli Schwartz: The planning committee has been meeting weekly and will continue until the conference. Lori Turner is assisting with finding volunteer interpreters and to do notetaking.

There will be four tracks at the conference.

1. Deaf-Blind community.
2. Legislative gains
3. Senior citizen focus topics and resources
4. Youth advocacy resources

There will be local and out of state speakers and people can choose which speakers to listen to. There will be community and youth panels as well as a vendor faire.

a) Deaf/Hard of Hearing (D/HH) Related Bills to be Revisited:

- [AB247 Overview](#) – **Died.**

Background

- i. AB 247 originally aimed to require closed captioning in public spaces (restaurants, bars, hospitals, waiting rooms).
- ii. Bill failed because it was combined with three other proposals, creating a fiscal note and confusion about scope.

- **Issues Identified**

- i. Misinterpretation by LCB: "Public spaces" assumed to mean government buildings, leading to cost concerns.

Combined bill included:

1. Closed captioning in public spaces (AB 247).
2. ASL as a foreign language credit for high school/college.
3. Deaf school community study.
4. Interpreter accommodations at public meetings.

- **Next Steps**

- i. Eli will:

1. Separate AB 247 from combined bill.
2. Draft a new BDR focusing solely on closed captioning upon request in public spaces (no fiscal impact).
3. Volunteers will research other components (ASL credit, Deaf school study, interpreter accommodations).
4. Reports to be submitted in Word format to Obioma before next meeting for review and faster voting.

- **Additional Notes**

- i. Legislator outreach should start early; build relationships before requesting support.
- ii. Engagement Conference and Deaf Day fundraising updates will be discussed at next meeting.
- iii. Goal: Have new BDR drafts ready by February meeting for approval and sponsorship.

- **AB395 Overview – Died.**
 - i. Discuss next steps (if any).
- **Background**
 - i. AB 395 aimed to improve accessibility for Deaf and hard-of-hearing patients in medical and healthcare facilities.
 - ii. Originally initiated by Shelly Freed.
 - iii. Bill died in the previous legislative session and needs review for reintroduction.
- **Next Step**
 - i. Shelly Freed will be contacted to confirm if she will lead the recommitment of AB 395.
 - Committee will:
 - 1. Locate the original BDR submitted for AB 395.
 - 2. Review and update language to remove any fiscal note and ensure feasibility.
 - 3. Updated draft to be ready by February meeting for discussion and approval.
- **Additional Notes**
 - Related bills discussed:
 - 1. AB 247 – Closed captioning in public spaces.
 - 2. SB 192 – Live interpreter requirement for birthing centers.
 - ii. Volunteers will research and submit Word-format reports to Obioma before the next meeting for review and posting.
- **SB192 Overview – Died.**
 - i. Discuss next steps (if any).
- **Background**

- i. SB 192 proposed requiring live sign language interpreters in birthing centers and hospitals upon request.
- ii. Bill died in the previous legislative session due to concerns about fiscal impact.
- iii. Other states have successfully passed similar legislation, providing a model for Nevada.
- Discussion

Obioma noted:

1. Hospitals are already required to provide interpreters upon request.
2. Birthing centers could mirror this requirement without significant additional cost.
3. Beth volunteered to research SB 192 and collaborate with Catherine for guidance.
4. Goal: Rework the bill to avoid fiscal note and align with existing hospital requirements.

- **Next Steps**

Beth will:

1. Contact Catherine for support.
2. Prepare a report on SB 192 for the February meeting.
3. Committee will:
 4. Review Beth's findings and vote on moving forward with a new BDR draft.
 5. Legislator outreach:
 6. Begin early relationship-building to secure sponsorship for the revised bill.

- [**SB352 Overview**](#) – **Vetoed by the Governor.** (Return to 84th Session) Watch to see if it comes back during the next session.
 - i. Discuss next steps (if any).

- **Background**

- i. SB 352 addressed discrimination by insurance companies.

Committee confirmed:

1. SB 352 was not initiated by the Deaf Commission.
2. No current action required by this group.

- **Discussion**

Obioma recommended:

3. Remove SB 352 from current agenda, but monitor future sessions for similar bills.
4. Ensure any future legislation does not discriminate against Deaf and hard-of-hearing individuals regarding insurance coverage for accessibility needs.
5. Eli agreed to keep SB 352 on the radar for future review.

- **Next Steps**

Committee will:

1. Watch for SB 352 or similar bills in the next legislative session.
2. Advocate for inclusion of Deaf and hard-of-hearing needs if insurance-related legislation resurfaces.

- **SB400 Overview – Passed.** Section 3 effective June 9, 2025. Section 1 effective July 1, 2025. Section 2 effective July 1, 2026.

- i. Discuss next steps (if any).

- **Background**

- ii. SB 400 was briefly mentioned as a bill to monitor, but no details were provided during the meeting.

1. Committee acknowledged the need to confirm the bill's relevance to Deaf and hard-of-hearing accessibility.

- **Discussion**

- iii. No substantive discussion occurred on SB 400 in this meeting.

Recommendation:

1. Research SB 400 to determine its scope and whether it impacts the Deaf and hard-of-hearing community.
2. If relevant, include in February meeting agenda for review.

- **Next Steps**

Assign a volunteer to:

1. Locate SB 400 in NELIS.
2. Summarize its purpose and potential impact.

3. Report findings at the next meeting for decision on whether to pursue or monitor.

7. For Possible Action: Discussion and Possible Vote to Approve Tentative Agenda Items for Next meeting, February 3, 2026.

- **Engagement Conference Outcome**

1. Obioma noted this will be included as an outcome report since the next meeting occurs after the conference.
2. Beth will provide a list of legislators contacted and responses regarding attendance.

- **Report on Bills Under Research**

1. Volunteers will research assigned bills (AB 247, AB 395, SB 192, SB 352, SB 400) and submit Word-format reports to Obioma before the next meeting.
2. Reports will be posted for review to allow faster voting during the meeting.

- **Update from Fundraiser for Deaf Day at the Legislature**

1. Beth suggested adding fundraising updates, including Sammy's Den and community efforts.
2. Obioma agreed to include this under a broad agenda item covering all fundraising activities.

- **Time Management Concern**

1. Eli expressed concern about limited meeting time (1 hour 15 minutes).
2. Obioma reassured that the current meeting stayed on schedule despite technical issues, and the next meeting should be manageable.

- The committee approved the following tentative agenda items for the February 3, 2026 meeting:
 1. Engagement Conference outcome.
 2. Reports on bills being researched.
 3. Fundraising update for Deaf Day at the Legislature.
- Reports must be submitted in Word format only (no images or graphics) to comply with open meeting laws.

- **Action Items**
- All Volunteers: Submit Word-format reports on assigned bills to Obioma before the next meeting.
- Obioma: Prepare and post agenda and meeting materials within two weeks.
- Beth: Complete legislator outreach and report responses.
- Committee: Prepare for February meeting to review and vote on BDR drafts.
