- ${\bf 3. \ \ Discussion \ \ Overview \ Regarding \ Open \ Meeting \ Law:}$

Cheyenne Pasquale, Aging and Disability Service Division (ADSD) Planning Chief and Susanne M Sliwa, Deputy Attorney General

- Open Meeting Law was established so the public would know what the government was going.
- Keeping governmental transparency and making actions of governmental bodies public.
- The Attorney General's office does have an Open Meeting unit that explores and prosecutes violators. The unit is in place to make sure that the law is followed, and the public has all the information.
- The Emergency Directive from the Governor's office has expired.

- Major legislative changes were made to the Open Meeting Law during the last session.
 One change allows for virtual only meetings. Requirements must be met to hold virtual only meetings, like having a call-in number.
- The public body may decide how to record votes.
- 4. Discuss, Review, and Approve Bylaws (For Possible Action): Cheryl Dinnell, Executive Director
 - Molly Walt motioned to approve the Bylaws as written, Cory Lutz second the motion.
 - The approval included the code of conduct and the ethics and etiquette.

- 5. Discuss, Review and Approve Proposed Meeting Schedule (For Possible Action): Cheryl Dinnell, Executive Director
 - Proposal of a November 18th meeting at 10:00am as made by Molly Walt, Cory Lutz second the motion, a discussion to determine the best date for the next meeting ensued.
 - With the Caregivers Recognition event on the 18th Molly Walt made a retraction of her motion and presented a new motion with the date of November 16th at 10:00am, Rachel Jelenic second the motion. All approved
 - Molly Walt motioned to have Carole Hanley send a doodle poll to the members prior to the November meeting so the dates could be narrowed down. Cory Lutz second the motion, all approved.
- 6. Presentation and Discussion regarding ADSD Lifespan Respite Care Act projects

 Jamie Ahumada, NWD Coordinator and Yaz Orozco, Respite Project Coordinator
 - Administration on Community Living (ACL) currently has 2 grants with Nevada: The Lifespan Respite & the Enhancement grant.
 - The Lifespan Respite grant is in its second year of a three-year grant that is developing a data minimum set agreement with state partners who provide respite services across Nevada.
 - The main goal is to be able to develop an annual report that shows information on Nevada's caregivers and their support needs. The data will be shared statewide to allow opportunities to advocate.
 - Having the information available will also provide options to collaborate and find gaps in respite and supportive services.
 - A flyer containing information on the Emergency funds for Caregivers should be released in the next couple of weeks.
 - More information on the goals for respite training and education, building and strengthening the workforce will be shared soon.
 - The Enhancement Grant is a 5-year grant which share like items with the Lifespan Respite grant. This grant can help develop and coordinated strategies to help recruit respite workers with internships and expand volunteers.
 - Nevada was recently selected as a pilot site for field testing training on core competencies
 for respite workers. The purpose of this pilot program will be to build and test respite
 workforce recruitment using the tools developed. Training and retention programs would
 meet the needs of families caring for individuals of any age or condition.
 - The goal over the next couple of years will be to obtain additional support for best practices in recruitment, retention, and training.
 - With the three projects having similar goals and objectives, they will be tied together as one single project instead of three separate ones.
 - Nevada Care Connection will still help identify caregivers throughout the state and connect them with services.
- 7. Presentation and Discussion regarding the ADSD Olmstead Plan Survey
 Nikki Haag, Public Information Officer and Cheyenne Pasquale, Planning Chief I

- States are required to have an established Olmsted Act; this act allows persons with a disability to receive support services funded by their state.
- ADSD will be sending out a letter to its Boards and Commissions members and the public asking to complete a survey giving input on the needs of the community.
- When the surveys have been received, ADSD will partner with an outside company to help develop the Olmsted Plan.
- It is estimated to take most of 2022 to collect and develop the Olmsted Plan.
- The Nevada Lifespan Respite Care Coalition is the first to have its own social media plan approved by ADSD. The sites supported by NLRCC are NVCaregivingRelief.org and its Facebook page and YouTube channel.
